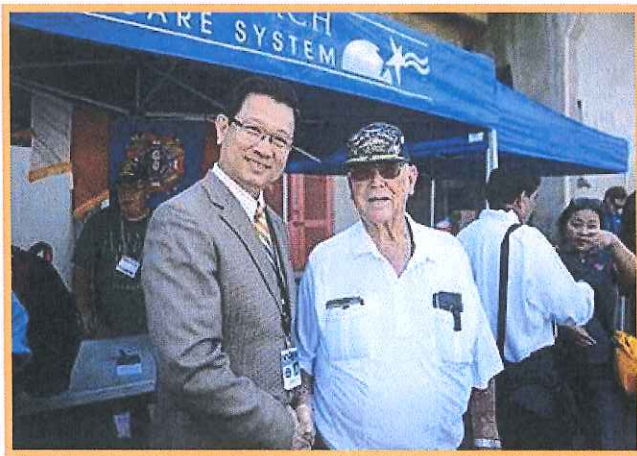
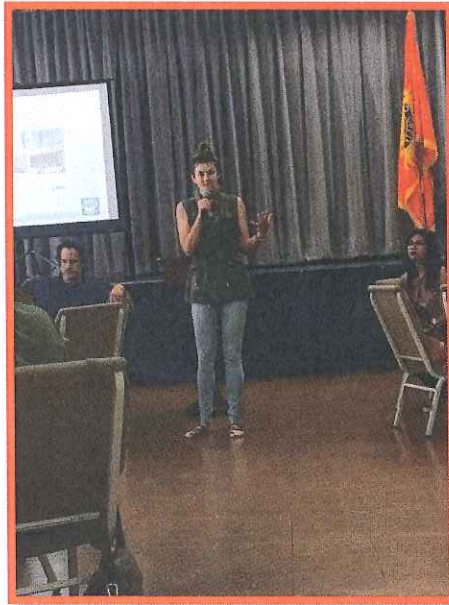

Stand UP for Veterans Event

On Thursday, April 20, 2017, Supervisor Do and OneOC's Stand UP for Veterans hosted a Veterans Resource Fair at the Santa Ana Municipal Stadium from 9 a.m. to 3 p.m. The fair was organized in a base camp model that included showers, meals, clothing, hygiene care kits, medical and legal advice, veteran benefit information, and employment services, in a safe and supportive environment. Participants were paired with a veteran peer navigator to guide them through the services that were offered. The first 100 who showed up received a "Barracks in a Bag" kit and other free supplies.

The event was held in partnership with the Office of Supervisor Andrew Do, the County of Orange, the City of Santa Ana, Honorable Councilmember Juan Villegas, and many other organizations.

2017 Affordable Housing Awards



The 35th Annual Affordable Housing Awards hosted by the Kennedy Commission, Orange County Community Housing Corporation/Stepping Up, and Affordable Housing Clearing House was held on Thursday, April 20, 2017. This year two developments supported through the County of Orange funding and resources were recognized.

Development of the Year Award – Rockwood Apartments, located in Anaheim, featuring 70 apartments is a joint venture between Jamboree and Innovative Housing Opportunities. This integrated development has apartments for large families, apartments set aside as permanent supportive housing for residents who receive services through the Mental Health Services Act (MHSA), and apartments for families who are part of the Homeless Assistance Pilot Program (HAPP), which is a collaboration among the City of Anaheim, the Anaheim Union School District and Illumination Foundation.

Innovative Development Awards – Potter's Lane is a first-of-its-kind eco-friendly affordable housing development constructed utilizing upcycled shipping. This innovative project reduces development costs, increases sustainability and energy efficiency, creates opportunities to leverage scarce resources and provides a solution to increased access to affordable permanent supportive housing without the long development cycles associated with conventional site-built construction and financing.

Central Service Planning Area: City of Santa Ana Awards 100 Project- Based Vouchers to two Projects

On April 4, 2017, the Santa Ana City Council approved the award of 100 project-based vouchers to help finance the development of two permanent supportive housing (PSH) projects. The two awarded PSH projects were the top-rated proposals submitted in response to the December 28, 2016, City of Santa Ana issued a Request for Proposals (RFP) soliciting applications for up to 75 Housing and Urban Development Veterans Affairs Supportive Housing (HUD-VASH) project-based vouchers for PSH for homeless veterans through the Housing First Model. The RFP also included additional affordable housing development funds and accounted for more than one project be selected.

The first project, Santa Ana's Veteran Village, proposed by Jamboree Housing Corporation (Jamboree) is a housing and service center for homeless veterans and was awarded 75 HUD-VASH project-based vouchers.

- **Service Partner:** Step Up on Second, Inc.
- **On-Site Resident Services:** case management services, employment assistance, psychological services, Veterans Administration services, legal services, and more
- **Location:** Intersection of West 1st Street and Kenton Drive
- **Type of Construction:** new construction development at a vacant site
- **Target Population:** homeless veterans that meet HUD-VASH program requirements,
- **Units:** 76 units – 71 one-bedroom and 5 two-bedroom units
- **Amenities:** multipurpose space, private meeting office, property management offices, a central laundry facility, a fitness room, a community kitchen, a community garden and barbeque grills.

The second project, Aqua Housing, proposed by Community Development Partners (CDP) was awarded 25 project-based vouchers.

- **Service Partner:** Mercy House
- **On-Site Resident Services:** intensive case management, with emphases on behavioral health and primary health issues, independent living skills, and employment and education goals
- **Location:** 317 East 17th Street
- **Type of Construction:** Acquisition, demolition, and new construction project on the site of an existing motel
- **Target Population:** chronically homeless residents earning at or below 60% area median income
- **Units:** 58 units – 15 studio units and 44 one-bedroom units
- **Amenities:** leasing office, office space for serviced providers, community room, a central courtyard and a community garden.

<p>Approval of the Memorandum of Agreement among Orange County, Anaheim, Garden Grove and Santa Ana Housing Authorities for inter-jurisdictional mobility.</p>	<p>Orange County Housing Authority (OCHA) collaborated with partner housing authorities in Orange County and developed a Memorandum of Agreement (MOA) designed to simplify, facilitate and improve inter-jurisdictional administration of the Section 8 Housing Choice Voucher Program, by eliminating cumbersome procedures that would otherwise be necessary under HUD's portability requirements.</p> <p>The MOA enables partner housing authorities to expedite service to assisted households that chose to relocate within the County of Orange. This MOA includes the City of Santa Ana Housing Authority along with the Anaheim, Garden Grove and the Orange County housing authorities. The new agreement will be effective May 1, 2017, to April 30, 2022. In addition, this MOA incorporates provisions for monitoring and performance of quality control inspections in conformance with requirements from HUD.</p>
<p>Potter's Lane Loan Funding Request</p>	<p>The Board of Supervisors approved American Family Housing request of a \$1,458,000 loan from 2016 Permanent Supportive Housing Notice of Funding Availability (2016 PSH NOFA) funds for a 16 unit affordable rental housing development, Potter's Lane, located in Midway City.</p> <p>Committing \$1,458,000 for the development of Potter's Lane supports the development of permanent supportive housing and affordable housing funding for homeless veterans as well as chronically homeless individuals. The County will leverage its prior commitment of eight project based U.S. Department of Housing and Urban Development Veterans Affairs Supportive Housing (HUD-VASH) vouchers and \$6,761,915 in permanent financing sources.</p>

North Service Planning Area: Collaboration between OCHA and City of Fullerton

On April 18, 2017, the Housing and Neighborhood Services Manager from the City of Fullerton contacted the Orange County Housing Authority (OCHA) regarding a housing program that was initiated by the city. The city's new Tenant Based Rental Assistance (TBRA) Program is funded with Federal HOME funds that will be used to make housing assistance payments for eligible elderly Fullerton residents, whose incomes are below 50% of the county median income. The City of Fullerton intends to offer up to two years of TBRA housing assistance to qualified senior households, with a possibility for a third year, based on funding.

The city approached OCHA to assist in an outreach effort to notify elderly Fullerton residents who are on OCHA's waiting list about this TBRA opportunity. OCHA immediately agreed to assist and collaborated with the city as follows:

- OCHA researched its waiting list applicants and identified 330 elderly residents of Fullerton who applied for housing assistance during the open enrollment period in February 2012.
- The city developed an information sheet to describe the program and instruct interested persons on how to apply
- The city will provided the information sheets in envelopes with postage and delivered these to OCHA on April 26.
- In order to protect the personal information of applicants on OCHA's waiting list, OCHA created mailing labels for the senior Fullerton applicants on the waiting list. OCHA staff applied these mailing labels and mailed the letters on April 26.

This was completed within 10 days of the request, and is a great example of a city-county collaboration to achieve mutually beneficial goals to expand housing resources that will positively transform the lives of our local elderly residents.

The Social Services Agency (SSA) deployed its Mobile Response Vehicle (MRV) to The Courtyard four times during the month of April and received 297 inquiries for services. Inquiries for services include eligibility determinations and re-determinations, as applicable for CalFresh, Medi-Cal, General Relief and CalWORKs.

Central Service Planning Area: Illumination Foundation's Recuperative Care Center

The County of Orange Director of Care Coordination, Susan Price, attended Illumination Foundation's Recuperative Care Center Open House in Midway City on April 25, 2017. Recuperative Care is a homeless shelter that serves as a stable discharge plan for local homeless who need a place to recover after medical treatment. The Recuperative Care Center in Midway City provides individuals with interim housing, daily meals, integrated medical oversight, intensive case management, mental health counseling, substance use counseling, connections to social services, transportation to and from medical appointments, and the opportunity to end their cycle of homelessness as they work towards self-sufficiency and permanent housing.

2nd Annual OC Real Estate Luncheon

In partnership with the Orange County Community Foundation (OCCF), the Second Annual Orange County Real Estate Luncheon was held Thursday, April 17, 2017 at the Hotel Irvine. The luncheon raised \$680,000 to support health, employment and educational programs for veterans in Orange County through the OCCF's Veterans Initiative. The County of Orange Director of Care Coordination, Susan Price, attended the luncheon and had an opportunity to meet with a number of stakeholders.

Behavioral Health Services

Behavioral Health Services (BHS) staffing includes staff members working Monday through Friday, 8:30 a.m. to 5 p.m. at The Courtyard and the Civic Center. BHS staff continue to coordinate with the Public Health Nursing Division and Social Services Agency to link participants to health services and register for benefit programs.

Civic Center

For the period of operation from March 20, 2017, through April 21, 2017, BHS Outreach & Engagement staff reported 513 outreach contacts at the Civic Center resulting in 82 referral services being made and an additional 22 confirmed linkages to services.

On Wednesday, April 12, 2017, BHS Outreach & Engagement team conducted a count of individuals staying in the Civic Center area, which includes Broadway to Flower, and Civic Center to Santa Ana Blvd. The count found 156 individuals – 106 individuals in the Plaza of the Flags and 50 individuals in the surrounding areas of the Civic Center.

- An increase of 18 individuals from the last count conducted in January 17.
- A decrease of 36 individuals from November 9, 2016.
- A decrease of 305 individuals from the Civic Center Homeless Survey done on August 23, 2016.

The Courtyard

For the period of operation from March 20, 2017 through April 23, 2017:

- BHS Outreach & Engagement staff reported 874 outreach contacts at The Courtyard resulting in 68 referrals for services being made and an additional 60 confirmed linkages to services.
- Mental Health Association (MHA) was contracted by the Orange County Health Care Agency to provide outreach during evenings and weekends at The Courtyard. MHA reported 924 outreach contacts resulting in an additional 167 referrals and 40 linkages to services.

Successes to Celebrate

Health and Lifestyle Improvements

A homeless client with multiple medical problems made remarkable health and lifestyle improvements with the help and support of a public health nurse from the CHAT-H Program over the past 6 months. The client now receives health care from a primary care provider and 5 medical specialists rather than from the emergency room. The client’s medical conditions are under control and medication has been reduced. Today the client manages diabetes through diet and exercise rather than medication, having lost 30 pounds. After receiving behavioral health care, the client feels positive and optimistic. Though the client is more confident in managing his health care needs, the public health nurse will continue to be available to assist as needed to support sustainable progress.

From Riverbed to Housing

In mid-spring, Illumination Foundation’s outreach team met CR and AC. At the time, they were living in the Santa Ana Riverbed. CR and AC wanted to engage the outreach team for some time due to the obstacles they faced every day, and it took several conversations to gain their trust. To establish this relationship, outreach team members provided short-term case management and basic needs. After some time, Illumination Foundation was able to connect these clients to Coordinated Entry System and place these clients into Micro-Communities, where they will have private rooms in a house with other formerly homeless individuals. Now they are housed, receiving ongoing case management, and addressing their needs.

Returning Home to Georgia

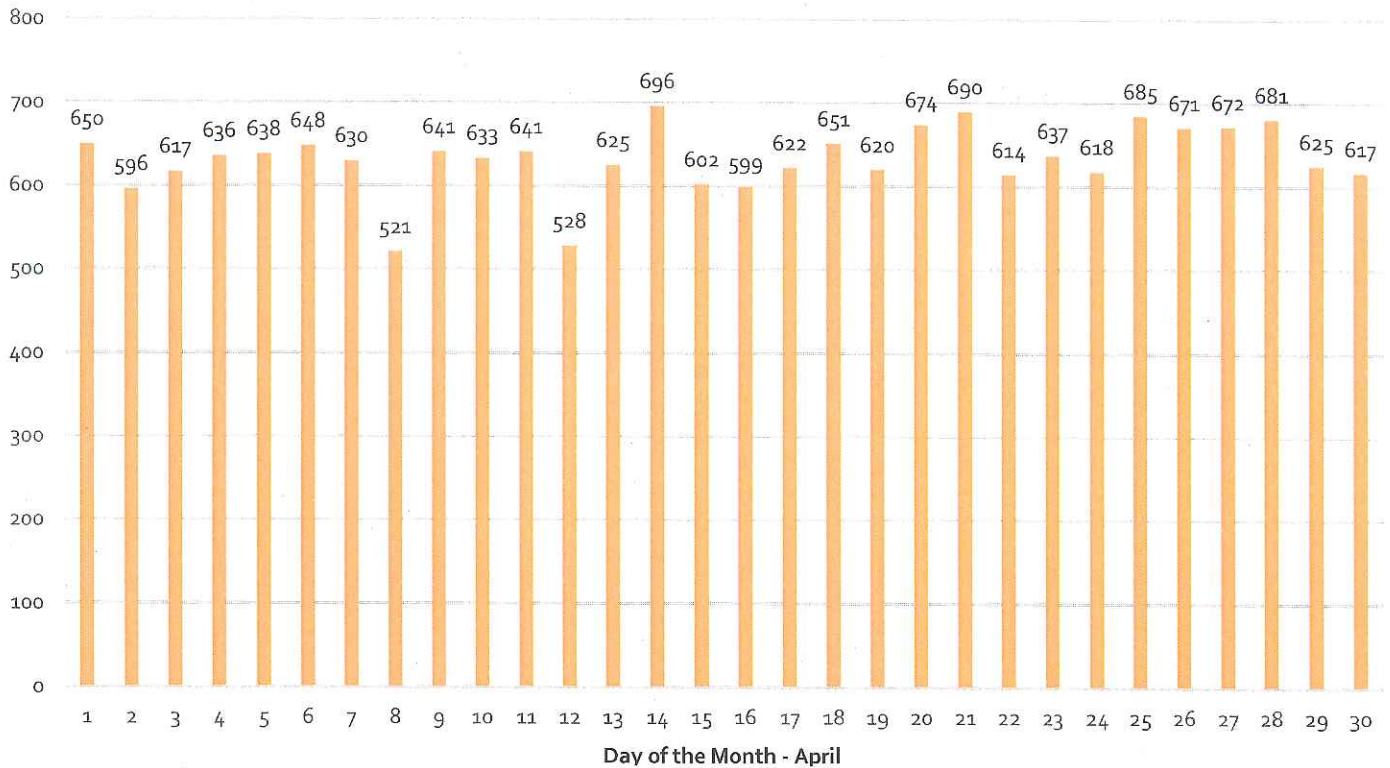
MG was asked to leave the house she was renting a room at due to overcrowding. MG became homeless and started staying in motels when she had sufficient funds. She went to Share Our Selves to seek resources and that is where they told her about the Courtyard. MG stayed at The Courtyard for a month. Through case management with City Net, they were able to reunite MG with her mother in Atlanta, Georgia.

Finding the Right Home

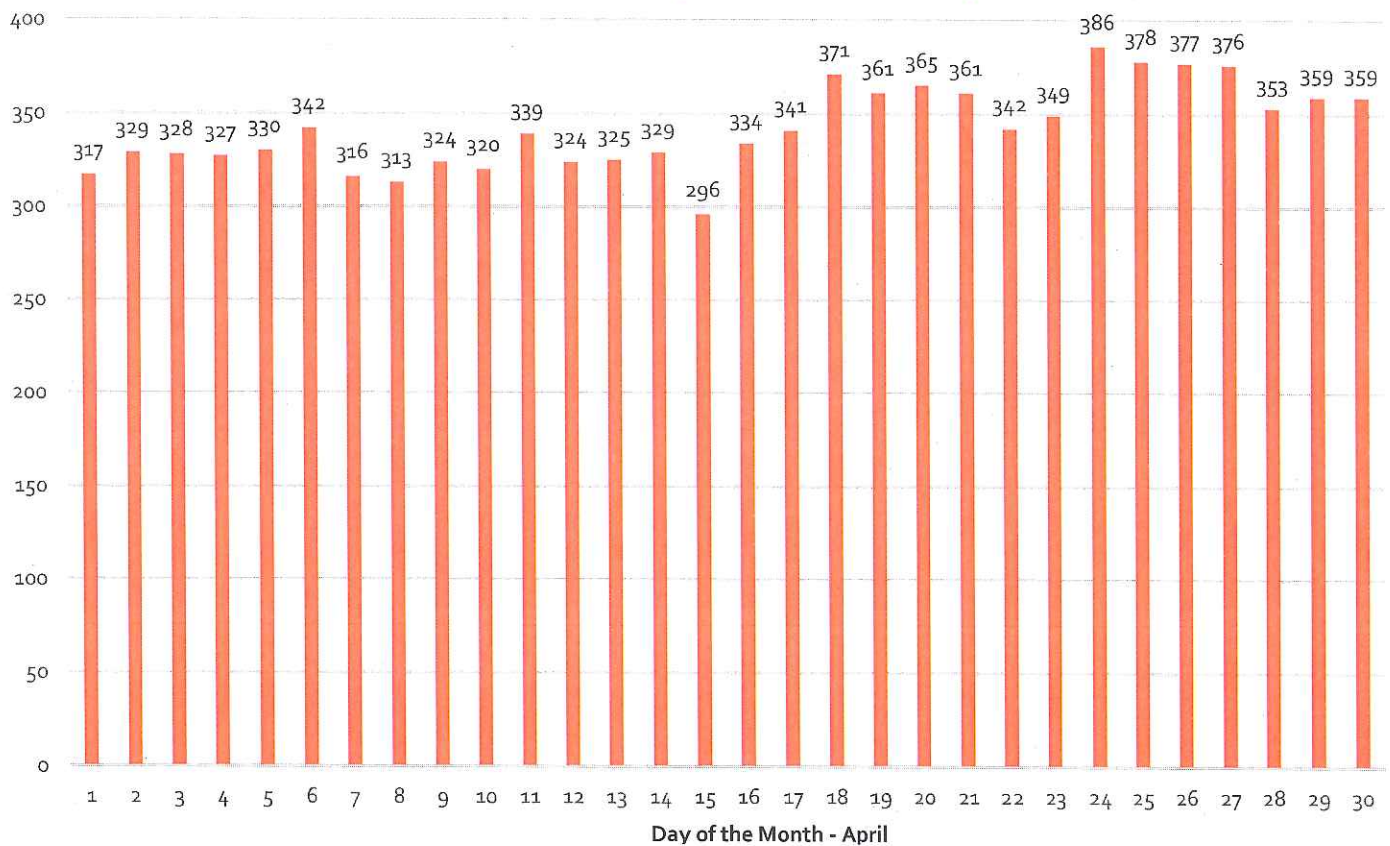
During the summer 2016, City Net staff met JC, 94-year-old man, in a Starbucks parking lot in La Habra. Prior to losing housing, he rented a room in the area. Over several months, City Net worked with him, City Net housed JC twice - once with a family member and once with a friend. Both times he lost housing and he returned to the Starbucks parking lot. City Net continued to work with him, and connected JC to a health care provider in La Habra to address his medical and physical health conditions. JC first arrived to The Courtyard in late March, after having been discharged from Chapman Medical Center. During his time at The Courtyard, City Net, The Midnight Mission, Health Care Agency Behavioral Health Services – Outreach & Engagement, and Illumination Foundation all worked together with JC and encouraged him to utilize the available senior housing options. The Midnight Mission connected JC with medical providers who work with a local skilled nursing facility and facilitated JC’s move. City Net is providing JC with ongoing case management.

ORANGE COUNTY POINT IN TIME COUNT 2017

Orange County's Point in Time (PIT) count occurred on January 28th, 2017. The PIT count is a biennial tally of people without a home on a particular night. We count because we want to understand homelessness in our community in order to end it. This PIT count provides vital information that guides and shapes the way we approach and solve homelessness in Orange County. This information is provided to the federal Department of Housing and Urban Development (HUD) and informs the amount and type of resources Orange County receives to help end homelessness.

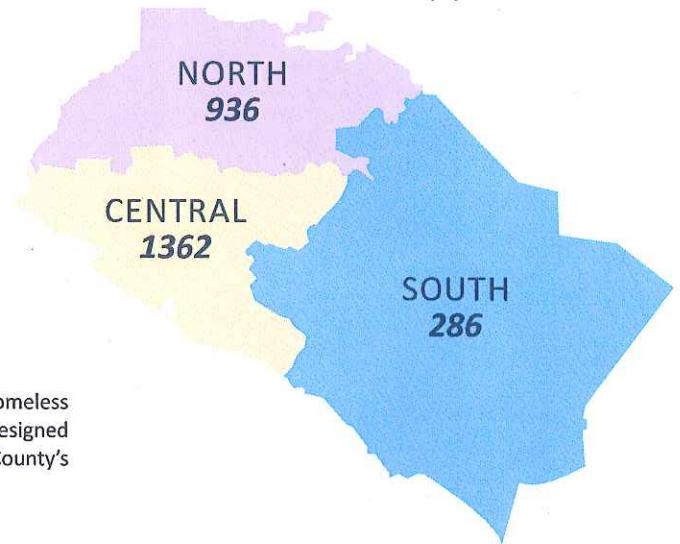

SERVICE PLANNING AREA MAP

Orange County is divided into three Service Planning Areas (SPAs) that efficiently direct resources as individuals experiencing homelessness enter the Coordinated Entry System.



CONTINUUM OF CARE

A Continuum of Care (CoC) is an integrated system of care that guides homeless individuals & families through a comprehensive array of services and housing designed to prevent and end homelessness. The County of Orange is the lead for Orange County's CoC, which funds 14 nonprofits across the OC CoC.

In conjunction with 2-1-1 Orange County, the OC Commission to End Homelessness convened an ad hoc committee to provide guidance on the 2017 PIT count project. The ad hoc committee's direction included a public places count with sampling methodology. This methodology was also used for the 2013 and 2015 PIT counts. During the 2017 PIT count, 86 additional maps were counted and surveyed for a total of 270 maps in comparison to 184 maps in the 2015 PIT count. Reductions in transitional shelter beds is reflective of national HUD funding priorities. Increase in emergency shelter beds is a result of The Courtyard, a County investment.

Reallocation of resources to permanent housing are not reflected in the count results.

SUBJECT: Monthly Water Usage Data, Tier 2 Projection & Water Supply Information

The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Tier 2 volume for MWDOC, and selected water supply information.

- Fig. 1 OC Water Usage, Monthly by Supply OCWD Groundwater water was the main supply in March.
- Fig. 2 OC Water Usage, Monthly, Comparison to Previous Years Water usage in March 2017 was below average compared to the last 5 years. Lower usage can be associated with the large amounts of rainfall that occurred in the previous month and the outfall of the SWRCB's mandatory restrictions that were set in June of 2015. In June 2016, all water conservation became voluntary for MWDOC agencies.
- Fig. 3 Historical OC Water Consumption OC water consumption is projected to be 511,000 AF in FY 2016-17 (*this includes ~15 TAF of agricultural usage and non-retail water agency usage*). This is about 18,000 AF more than FY 2015-16 and is about 52,000 AF less than FY 2014-15. Water usage per person is projected to be slightly higher than in FY 2016-17 for Orange County at 144 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts.

MWDOC "Firm" Water Purchases, 2016 "Firm" water above the Tier 1 limit will be charged at the higher Tier 2 rate. Tier 2 purchases are zero in 2017.

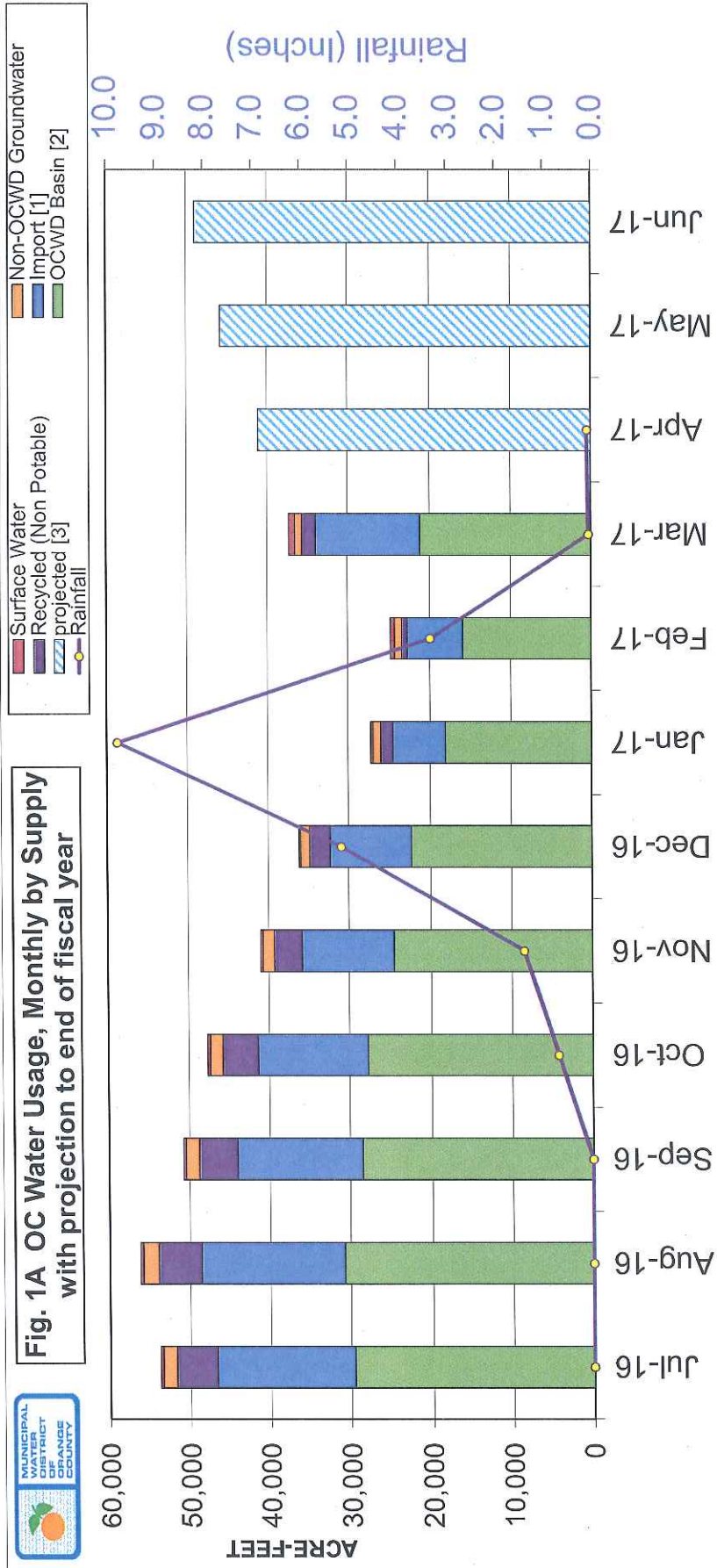
Water Supply Information Includes data on: Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data has implications for the

magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

- Orange County's accumulated rainfall through April was well above average for this period. Orange County has had below average rainfall for the past 5 hydrologic years.
- Northern California accumulated precipitation through April was around 203% of normal for this period. April 2017 rainfall well above the historical average for that month. The Northern California snowpack is 198% of normal as of May 1st. The State of California was in a declared Drought Emergency that started January 2014 and just recently ended in April of 2017. As of late April drought conditions have improved significantly and only 8% of California is still suffering from moderate or severe drought. The State Water Project Contractors Table A Allocation has increased to 85% as of the end of April.
- Colorado River Basin accumulated precipitation through April was 119% average for this period. The Upper Colorado Basin snowpack was 122% of normal as of April 3rd. This follows five below-average hydrologic years; the Colorado River Basin is in the recovery of a long-term drought. Lake Mead and Lake Powell combined have about 65% of their average storage volume for this time of year. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries for the Lower Basin states. As of late April Lake Mead levels were 13' above the "trigger" limit. The USBR predicts that the end of 2017 or the end of 2018 will not hit the "trigger" level.

Fig. 1B O.C. Historical Water Usage

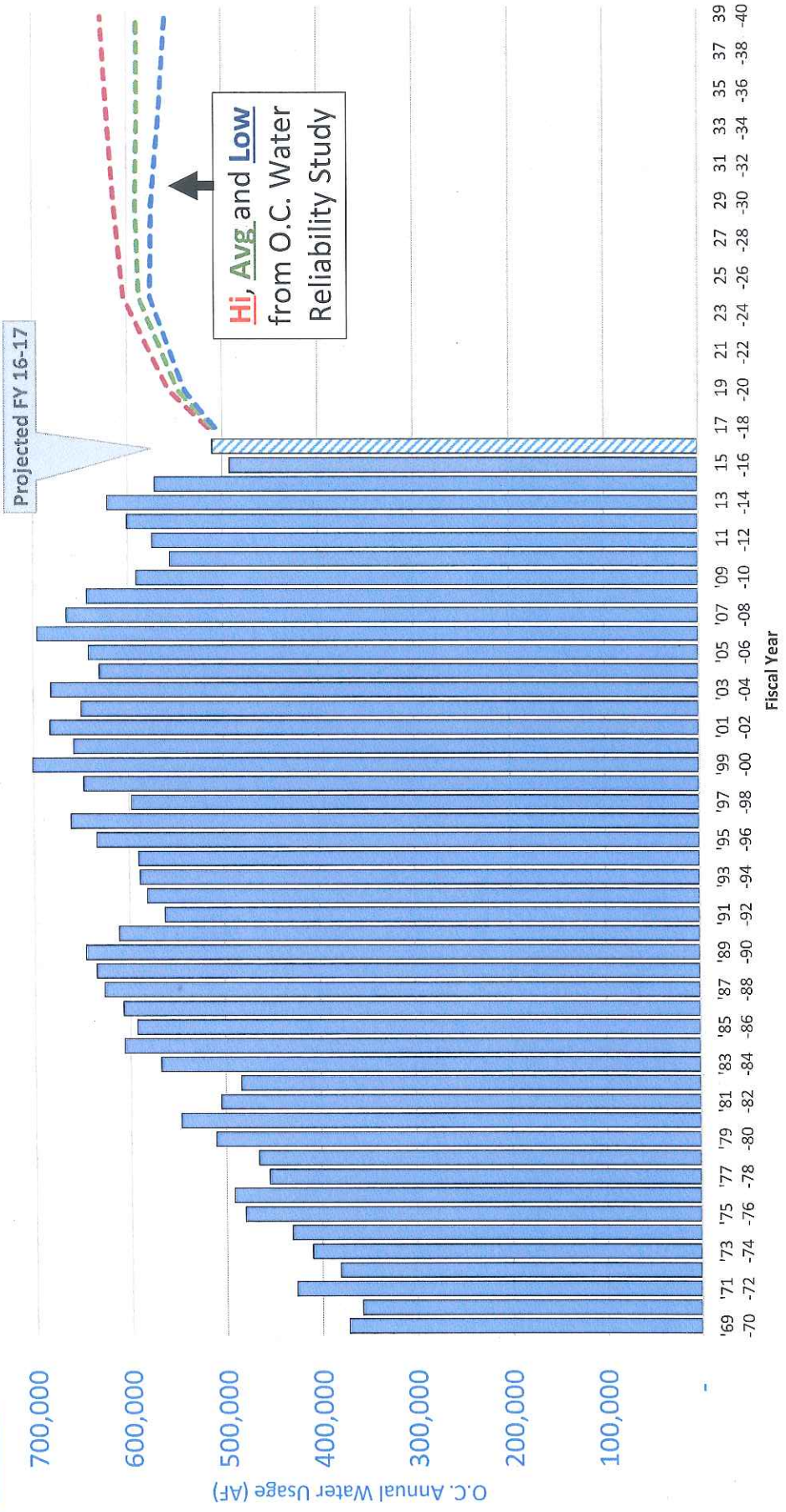
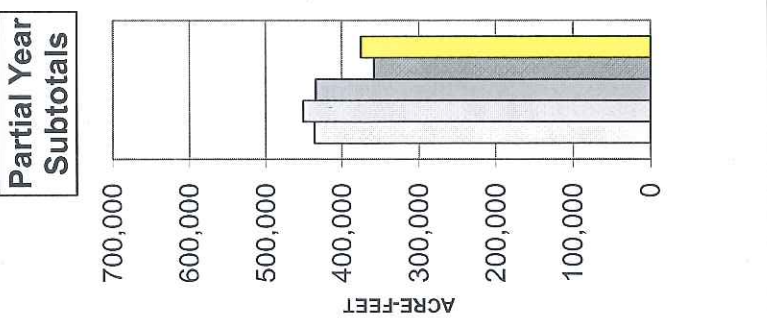
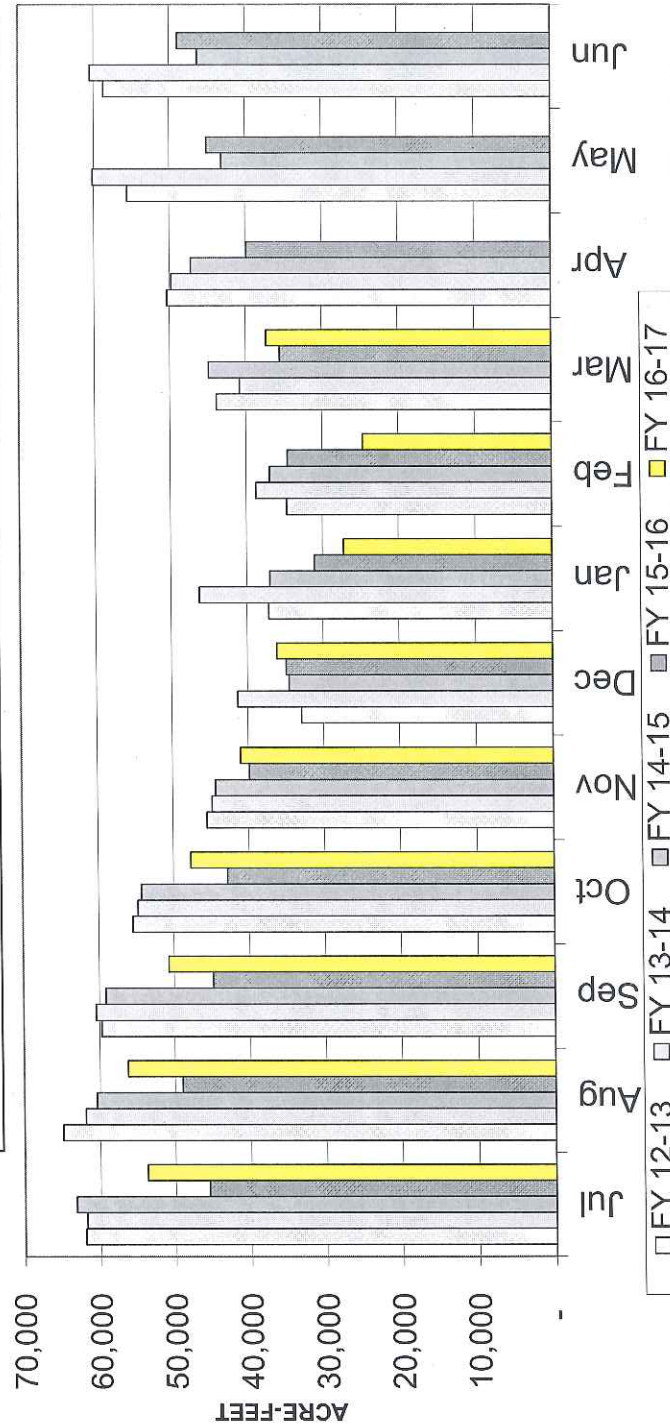


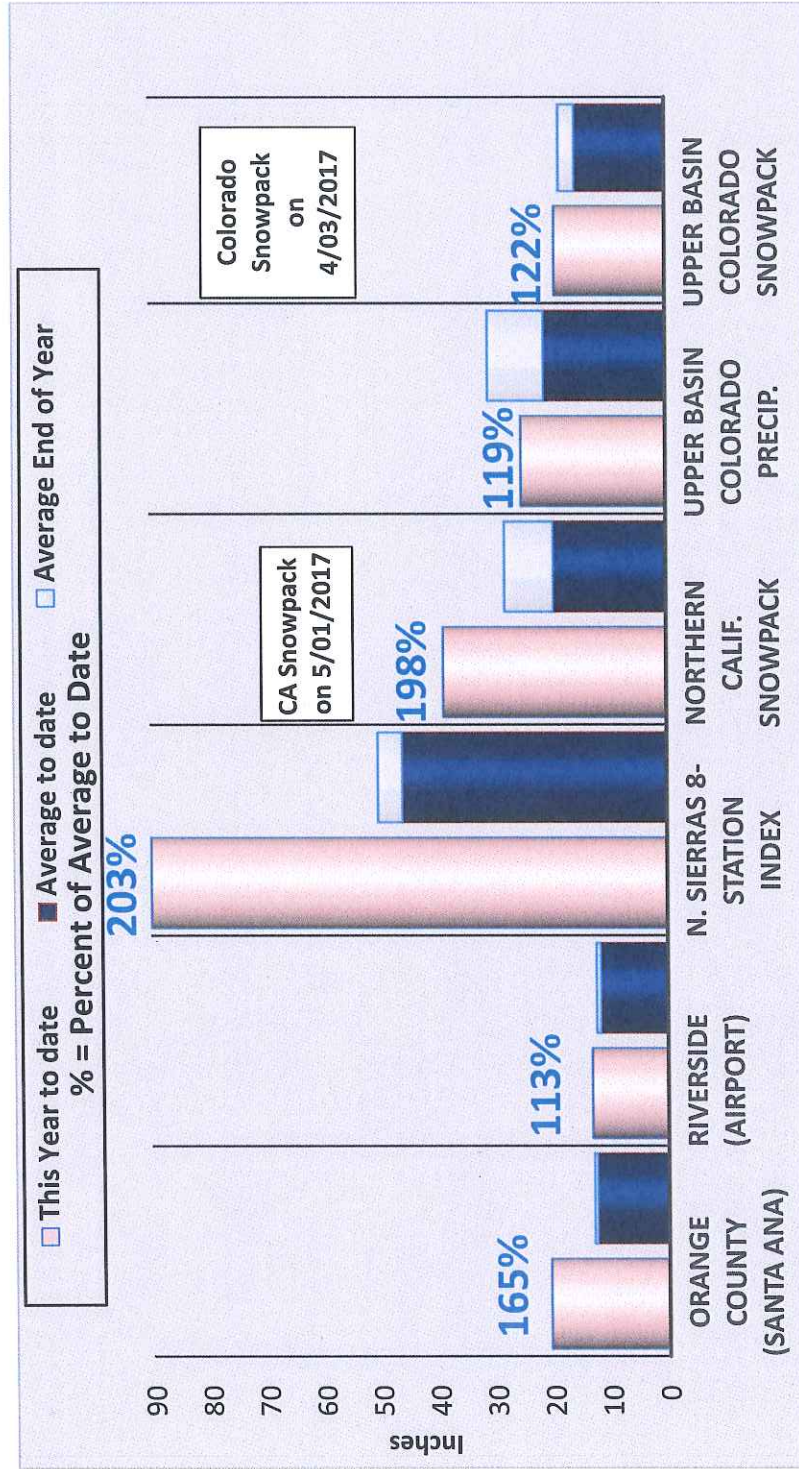


Fig. 2A OC Monthly Water Usage [1]: Comparison to Last 4 Fiscal Years

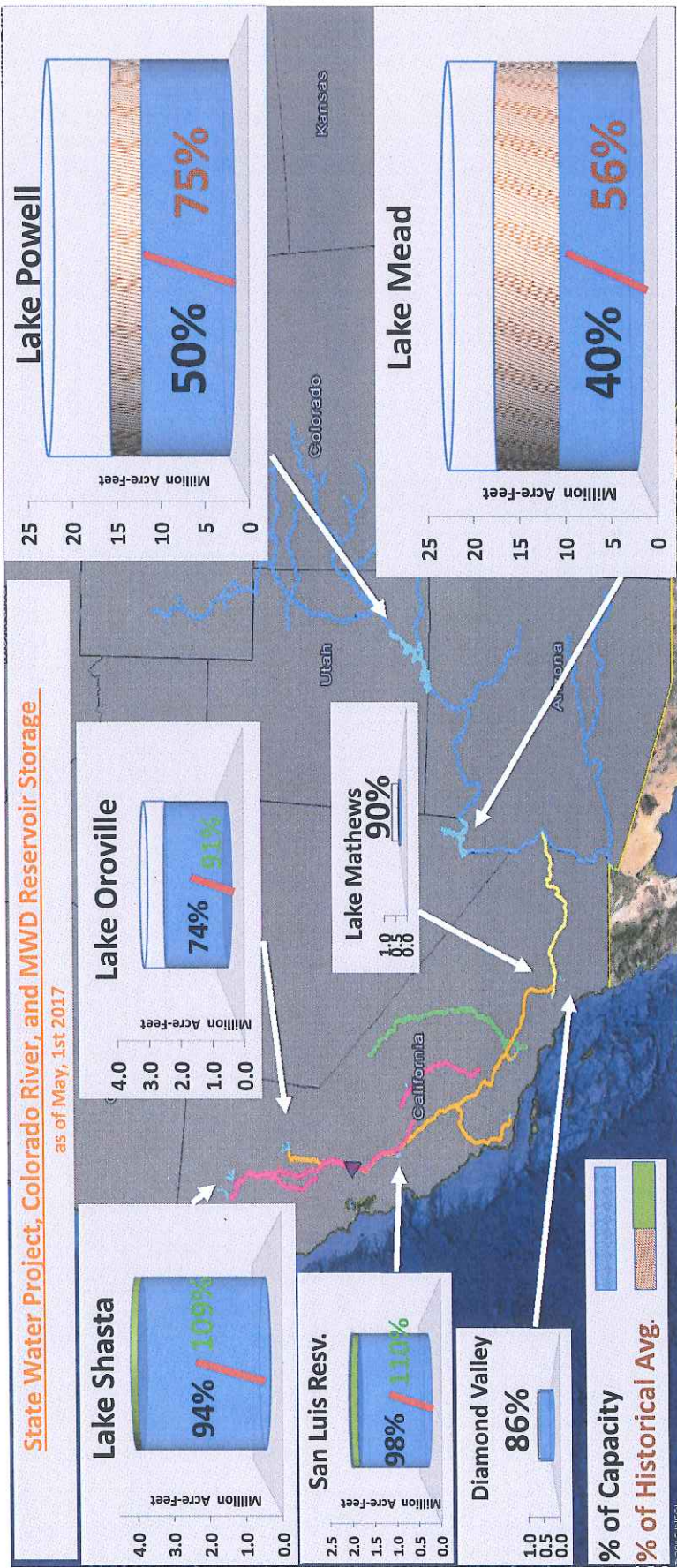
Accumulated Precipitation for the Oct.-Sep. water year, through April 2017

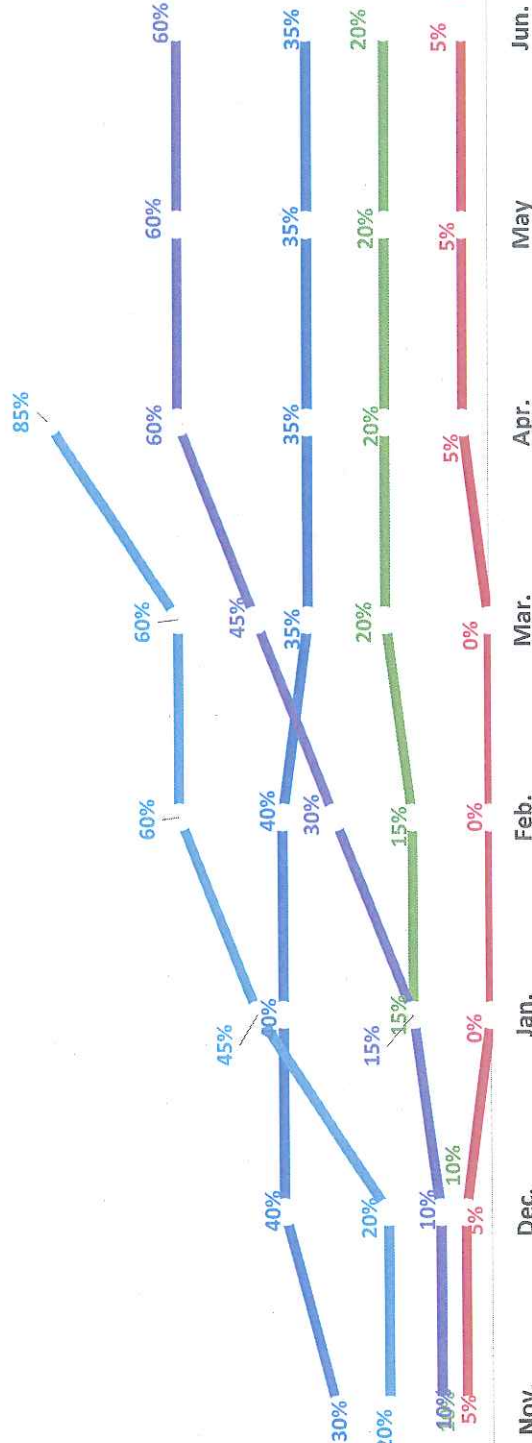

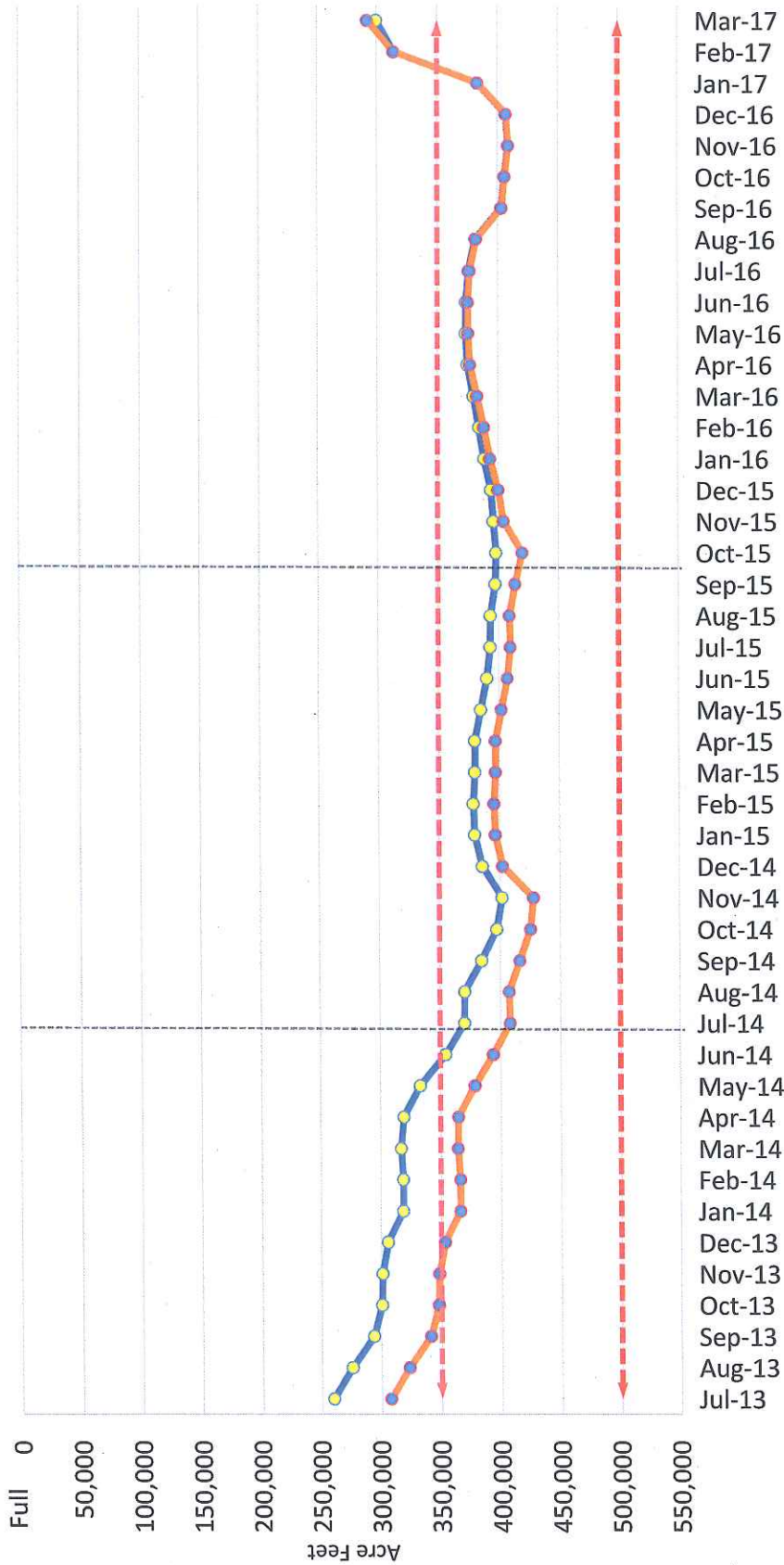

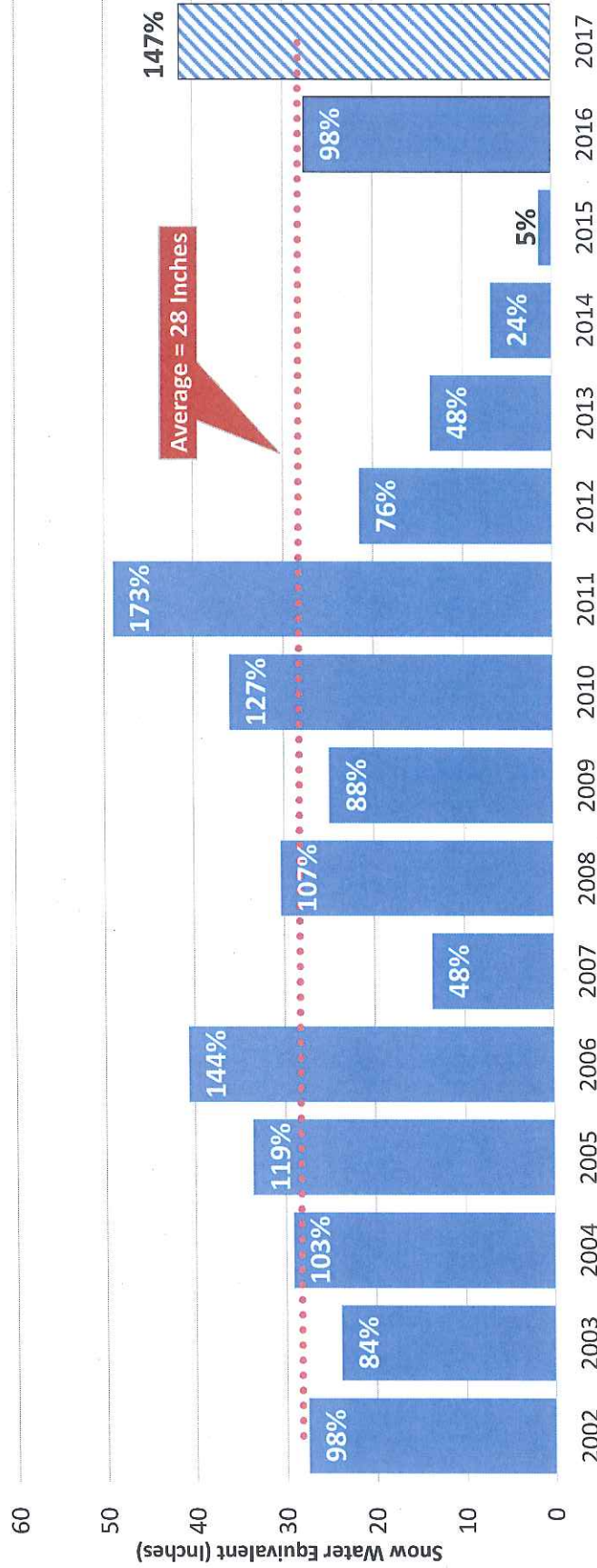
Accumulated Overdraft of the OCWD Groundwater Basin as of March 2017



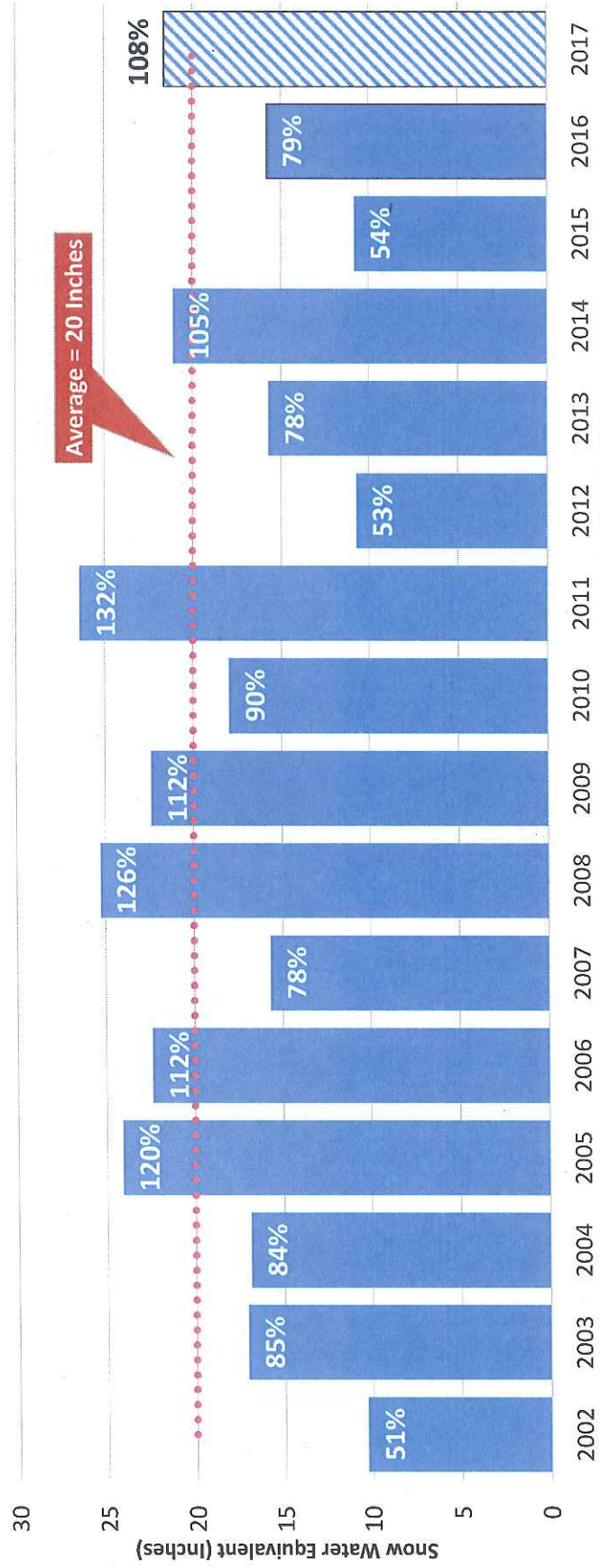

SUMMARY

On May 1, 2017, Southern California Edison Company (SCE) filed an application with the California Public Utilities Commission (CPUC) requesting review and approval of its Energy Resource Recovery Account (ERRA) Forecast Application. This application will review SCE's estimate of costs associated with certain aspects of its business operations for 2018. These costs include SCE's purchases and production of energy for its customers. SCE's application is seeking a decrease in revenue, as described further below.

ABOUT THE PROPOSAL

The CPUC has established the ERRA Forecast Application as the process for review and approval of SCE's estimate of the costs of fuel that it will need to generate electricity. This application also reviews the costs of additional power it purchases for its customers. This information is provided to the CPUC for the purpose of determining SCE's rates related to the purchase of fuel and purchased power.

In addition to estimating fuel and purchased power costs, SCE's 2018 ERRA Forecast Application includes:

- (1) A request to approve other expenses recoverable in ERRA proceedings, such as expenses related to spent nuclear fuel (stored nuclear fuel that has already been used); and
- (2) A request to approve SCE's 2018 forecast of Greenhouse Gas (GHG)-related costs and revenues to be returned to customers.

SCE's proposed revenue requirement is \$4.183 billion for 2018. This request represents a decrease of \$302 million from SCE's current 2017 ERRA-related revenue requirement, or a 2.28% system average rate decrease. The revenue decrease proposed in this application will result in a decrease to customer rates of approximately 0.36 cents per kilowatt-hour as compared to current rates.

If SCE's proposed ERRR rate change is approved, an average non-CARE residential electric customer would see a bill decrease of \$2.36 per month, from \$107.30 to \$104.94.

This application is a forecast and is likely to change prior to including these costs in next year's electric rates. Consistent with past ERRR Forecast applications, SCE expects to update this application in November 2017, so that the latest forecast assumptions can be incorporated into SCE's 2018 rates.

On May 5, 2017, Southern California Gas Company (SoCalGas®) filed an application with the California Public Utilities Commission (CPUC) for approval to increase rates for the implementation of the Mobilehome Park Utility Upgrade Program (MHP Program). This application seeks approval to implement the MHP Program to convert mobilehome parks to direct utility service for a period of six years (2018-2023). Converting mobilehomes to direct utility service will increase safety and reliability of gas and electric service to MHP residents, facilitate customer enrollment in SoCalGas' current customer assistance programs offerings, and provide MHP customers with Advanced Meters. In March 2014, the CPUC issued Decision (D.) 14-03-022 to adopt a three-year pilot program to convert at least 10% of master-metered and submetered mobilehome parks to direct utility service. The decision gave utilities the option to seek continuation of the program after the three-year pilot program. SoCalGas' Mobilehome Park Utility Upgrade Program is a continuation of the three-year CPUC approved program. SoCalGas requests approval to convert an additional 20% of mobilehome spaces within its service territory from 2018-2023.

As shown below, SoCalGas is requesting annual revenue requirement increases due to this program for the years 2018 through 2023. If approved, the increase in each annual revenue requirements would be charged to customers over a 12-month period, or until the costs are recovered. The proposed annual rate increases are shown in the tables below reflecting the revenue requirements.

ESTIMATED IMPACT OF THIS REQUEST ON GAS RATES

SoCalGas has estimated increases in annual revenue requirements of \$0.5 million in 2018, \$3.9 million in 2019, \$12.5 million in 2020, \$22.5 million in 2021, \$32.4 million in 2022 and \$40.3 million in 2023. The table below shows the year with the biggest request increase compared to current rates.¹ The actual rate increase to each customer class by year would depend on how the CPUC ultimately decides all issues in the proceeding.

Congressman, students discuss ins and outs of civics

Alan Lowenthal visits Pacifica, Garden Grove high schools

Area Congressman Alan Lowenthal visited Pacifica and Garden Grove high schools last week in an effort to give students a chance to ask questions and gain insight into the legislative process.

Lowenthal visited a senior class assembly at Pacifica High, where he discussed details about having served in Congress and current policies being debated in Washington.

Lowenthal's visit came after students had written letters expressing their opinions about pending legislation.

All of the seniors were asked to write a question they wanted to ask the Congressman, then those questions were pared down to the most eloquently written, with eight students being selected.

Student Taylor Howard asked about the environment; Joanna DeWitt: healthcare; Alexis Gonzalez and Sydney Arellano: higher education costs; Jesus Ruiz, LGBT issues; Nikki McConnaughey: lobbyists; and Bekka Galperin: veterans affairs.

"California is different than any other state in the nation," Lowenthal told students. "We are ethnically different and... in terms of protection of the environment. We are an inclusive state.

Lowenthal said the country is going through interesting times.

"Before this last election, people didn't get involved as much. I used to hold a town hall meeting with maybe 100 people

but recently in Los Alamitos, 1,000 people showed up... In Congress, the Obamacare bill was replaced with a bill that I didn't agree with and didn't vote for."

Lowenthal said he believes in universal healthcare.

"We have to regulate the insurance industry so that every plan protects everyone."

Lowenthal said affordable care should provide essential services for everyone but that the proposed healthcare bill has left it up to each state to decide on hospitalization and mental health care and if people want to join.

"Obamacare went according to what a person earned; the new one takes away that guarantee and many people will lose their healthcare. Now it will be up to Trumpcare and the Senate."

Lowenthal expressed concern about Scott Pruitt and the EPA.

On North Korea, Lowenthal said, "Their leader is dedicated to building a missile that will reach the U.S. and North Korea's neighbors are very concerned that he could cause problems for

South Korea and China."

Lowenthal said we should put sanctions on North Korea.

"So far, everyone is on board with the United States and its allies," he said.

Lowenthal said China is not the U.S.' ally right now and that China helped North Korea to have materials to make missiles.

"We need to look at how to get China to work with us and that's very risky because China also has its own agenda."

On helping women in college, Lowenthal said they Congress has made Pell Grants available, interest rates on loans have been lowered and there are more scholarships offered.

Lowenthal said her supports Senator Bernie Sanders' push for free public college.

On human rights Lowenthal said, "I want full equality rights to become more democratic and am a co-sponsor of the Equality Act. We have nations in the world where people can be put in jail for being LGBT."

While waiting for Lowenthal to arrive at Pacifica, social sciences teacher Leslie Ross had a bag of treats she handed out to students who could correctly answer trivia questions.

There were plenty of answers, with the sweet treats going to the most knowledgeable students.

Principal Robin Patterson praised Lowenthal for taking the time to visit.

"Congressman Lowenthal works for the betterment of all people and communities and understands the give-and-take necessary to achieve results, while serving people of California and the nation," said Patterson.

Lowenthal previously served on the Long Beach City Council, California State Assembly and California State Senate.

"He has worked hard to make the California college system more accessible to all students

Little Saigon activists, officials ready to fight Assembly bill

AB22 would kill law allowing state to fire workers who are members of the Communist Party

Little Saigon officials and activists said they are gearing up to fight a proposed California bill that would prevent the firing of public employees for being affiliated with the Communist Party.

The bill, AB 22, passed the state Assembly this week by a 41 to 30 margin — with no support from the Orange County delegation. If the bill passes the state Senate, it would change a law that dates from the height of the Cold War in the 1950s and singles out Communist Party membership as grounds for firing state workers.

The prospect of allowing Communist Party members to work for California has riled Little Saigon. Most in the community are either refugees or relatives of refugees who fled their homeland after the fall of Saigon in 1975 to communist forces. Orange County's Little Saigon is the largest concentration of Vietnamese outside of Southeast Asia.

"I am disappointed in the Assembly," Westminster Mayor Tri Ta said. "It feels like they betrayed our community."

The Westminster City Council on Wednesday, May 10, unanimously passed an emergency resolution to send a letter to the state legislature condemning the bill. Garden Grove leaders have asked their staff to prepare a similar protest.

Garden Grove Councilman Phat Bui said he is also working with local activists to send protesters to Sacramento.

"We sacrificed so much — not just Vietnamese, but American veterans as well — fighting communism," Bui said. "The communist doctrine is opposed to the American way of life."

The law, as originally written, also allows the firing of an employee who belongs to any organization that advocates the "overthrow of the government of the United States." But fear of communism is explicitly mentioned in its opening paragraphs as the motivation.

The new bill, authored by Assemblyman Rob Bonta (D-Oakland), would strike the introduction and reword the law to allow public employ-

ees to be fired only if they are members of organizations they know want to, and are seeking to, overthrow the government by force or violence.

Bonta said his bill is a "technical cleanup," meant to align California law with the United States Constitution and the ruling of the Supreme Court in the 1967 case *United States v. Robel*. In that case, the Supreme Court ruled, in essence, it is unconstitutional for the government to fire people because of their political affiliations.

"This bill certainly doesn't endorse communism or encourage communism," Bonta said. "The bill stands up for people's rights."

Trying to overthrow the government has always been illegal and the bill wouldn't change that, Bonta added.

But it will be a hard sell for those who represent the Vietnamese community.

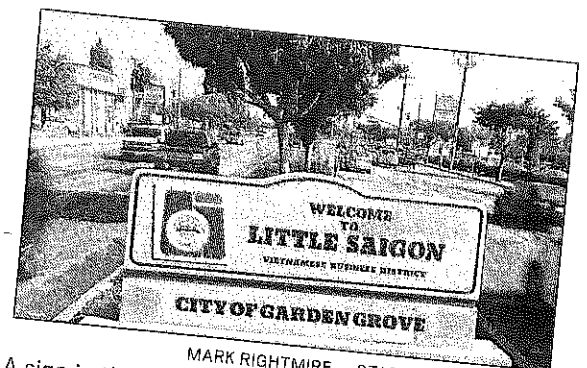
State Sen. Janet Nguyen, a Republican representing Garden Grove, has vowed to vote no on the bill if it comes to the Senate floor. She has started a petition opposing it.

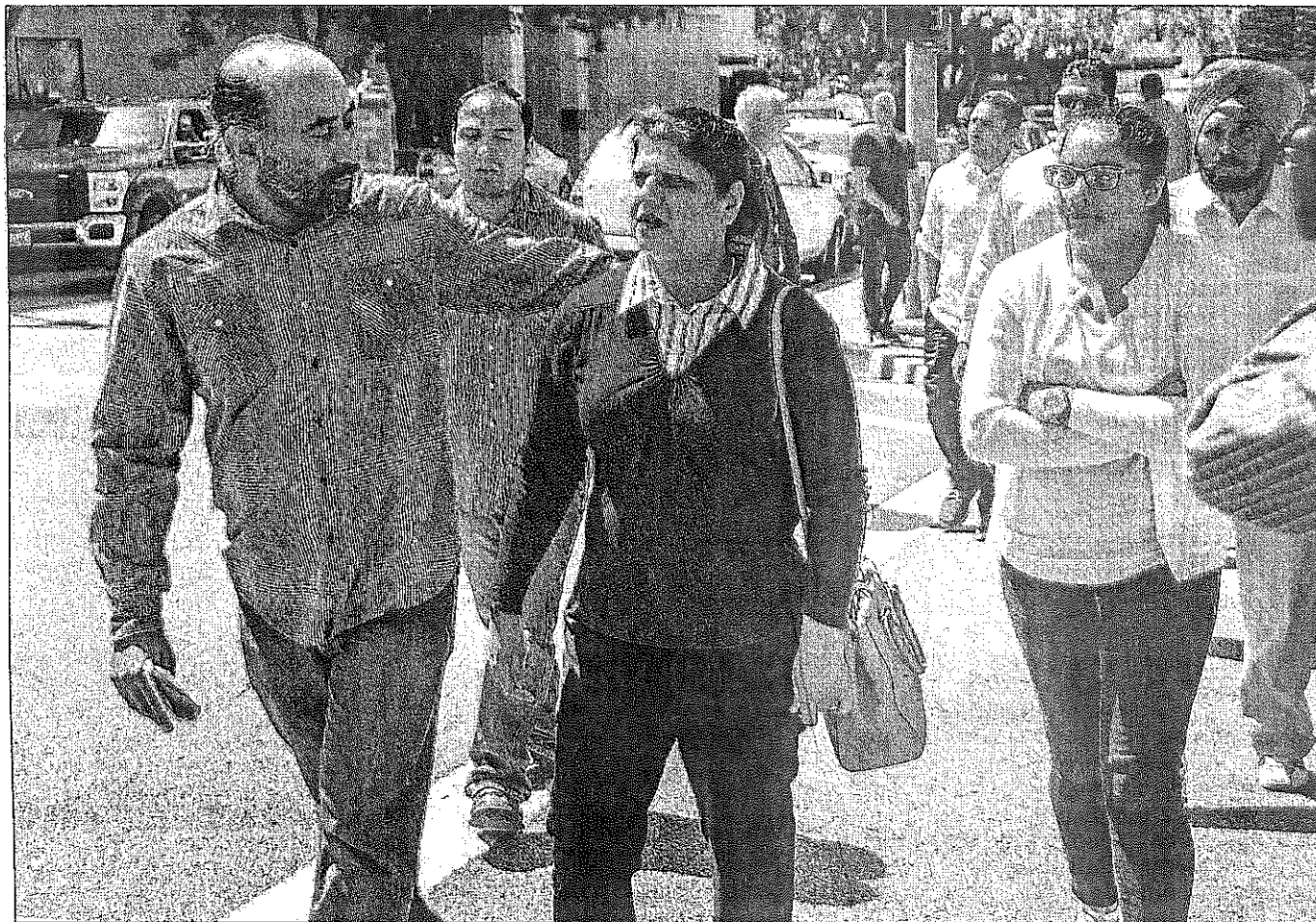

A longtime Garden Grove resident with deportation orders and no criminal record is detained by ICE, leaving his and his family's future uncertain

SANTA ANA » Gurmukh Singh, a Garden Grove resident and family man with no criminal record, entered a federal building with his wife, two daughters and a pro bono attorney May 8 to check in with U.S. Immigration and Customs Enforcement, as required for individuals with final deportation orders who have been released under supervision.

An asylum seeker, Singh, 46, said he was "very nervous."

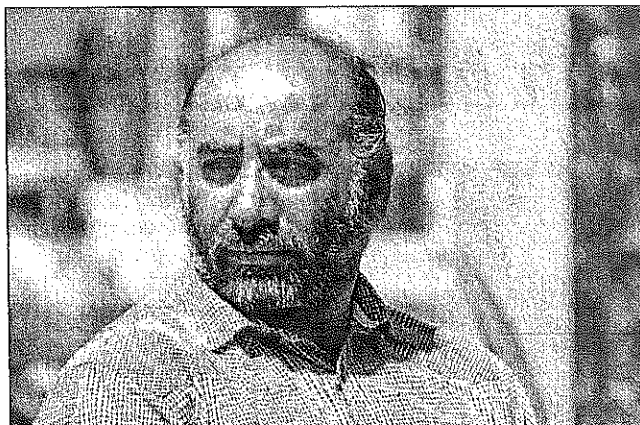
The taxi driver had been taken into ICE custody once before, in 2013, when he interviewed for legal permanent resident status unaware of his outstanding deportation order. Immigrants' rights groups and politicians successfully advocated for his release, but two weeks ago, a judge dismissed Singh's appeal to reopen his asylum case.

"I would be broke, the fam-

ily separated and we're not supposed to be separated," Singh said of the prospects of detention and deportation.

Singh prayed with dozens of family members and supporters outside 34 Civic Center Plaza before walking in.

He didn't come back out.

"The look on his face told me there was nothing that could be done," said Singh's oldest daughter, Manpreet Saini, 18. "He breaks down. He's crying. I've never seen him cry like that."

It's unclear where Singh will be detained and the timeline for any actions ICE may take. Various groups and local elected officials have vowed to ramp up efforts to demand his release.

ICE has discretion to grant a stay of removal, and immigration officials often did so under the Obama administration, which ordered that non-criminal detainees were not the priority for deportation proceedings. However, Monica Glicker, Singh's volunteer attorney through Asian Americans Advancing Justice — Orange County, said "that conversation did not go anywhere" on May 8.

"They didn't even take us into an office. Two ICE agents on each side allowed him a moment and took him away," Glicker said.

The Trump administration has directed Department of Homeland Security personnel to prioritize enforcement efforts on those who been convicted of a criminal offense, charged with a criminal offense that has not been resolved, or are subject to a final order of removal but have not complied with their legal obligation to leave the country.

"While criminal aliens and those who pose a threat to public safety will continue to be a focus, DHS will NOT exempt classes or categories of removable aliens from potential enforcement," ICE spokeswoman Virginia Kice said May 8 in an email.

Singh immigrated to the U.S. in 1998 without inspection — escaping religious persecution in India — and applied for asylum the following year. His previous counsel did not notify him in advance of his court date

in 1999 and did not prepare him, so Singh appeared at the hearing without supporting evidence or testimony, according to Glicker. In addition, his original attorney failed to inform Singh that the judge issued a deportation order.

It wasn't until Singh's wife, Balwinder Kaur, became a U.S. citizen in 2010 and applied for him to become a legal permanent resident in 2012 that he found out he had a deportation order on his record. During the interview, immigration officials took Singh into custody and he was detained at the California City Correctional Center for 5 ½ months.

Immigrants rights groups RAIZ and the Asian American justice center fought for his release, and Rep. Alan Lowenthal, D-Long Beach, said ICE gave him a verbal agreement that the agency would not proceed with Singh's deportation.

For years, Singh has attended his regularly scheduled appointments with ICE and been an "exemplary citizen," acting as the breadwinner and taking care of his teenage daughters, parents and wife, who has diabetes, Lowenthal said.

"So Mr. Singh has lived up to his part of the bargain," Lowenthal said before Singh entered the building on May 8. "Now it's time for ICE to live up to their part of the bargain."

Singh tried to reopen his asylum case in the Ninth Circuit Court of Appeals, arguing ineffective assistance from his previous counsel, but a judge dismissed his appeal on April 25.

ICE's decision to take Singh into custody May 8 was based on a deportation order handed down by an immigration judge with

the Department of Justice's Executive Office for Immigration Review in 1999, according to Kice.

"Over the last 18 years, Department of Homeland Security databases indicate Mr. Singh's case has undergone exhaustive review at all levels of our nation's legal system, including scrutiny by local immigration judges with EOIR, the Board of Immigration Appeals, and the Ninth Circuit Court of Appeals," Kice wrote. "After examining the facts of Mr. Singh's case, the courts have all upheld his original removal order."

Rep. Lou Correa, D-Santa Ana, said that since Trump became president, it's become "very much typical" in his district for "honest, hard-working" people like Singh to face deportation.

"I get calls every week," Correa said during the rally Monday for Singh. "There is something wrong with our immigration system when people like Mr. Singh are denied the American dream."

Lowenthal last Thursday introduced a private bill for permanent resident status for Singh, but he is not eligible until his deportation order has been resolved, Glicker said. If he is deported, he can apply to return to the U.S., but the process could take at least five years.

While Singh's future is uncertain, so is his family's.

Saini, 18, who attends Rancho Alamitos High School, said she has been accepted to Cal State Fullerton and Cal Poly Pomona but may have to find a job instead of pursuing her education to help make ends meet.

"Without him," she said, "we would not be able to pursue our dreams."

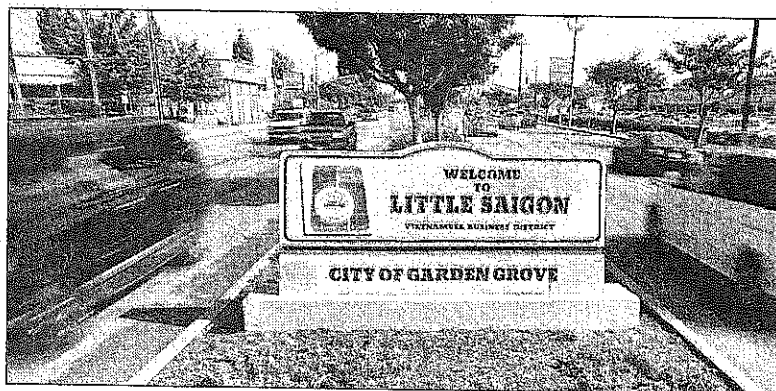

Bonta said he understands why the Vietnamese community dislikes this bill, and drew a distinction between what he described as the "McCarthyite, paranoid" intent of the current law and the visceral, traumatic experiences of Vietnamese Americans.

"Everyone from the Orange County delegation will have a tough time with this bill and I totally understand why," he added. "But I hope they try to understand the bill and its intent. It is meant to bring California in compliance with the Constitution."

Governor Signs Legislation Restoring Funding to California's Four Most Recently Incorporated Cities

Affected Cities are Eastvale, Wildomar, Menifee and Jurupa Valley

Jurupa Valley, one of the four cities affected when the state swept the remaining shares of the city vehicle license fee (VLF) funds, was the site of Gov. Jerry Brown's signing ceremony this morning for SB 130 (Committee on Budget and Fiscal Review). Sen. Richard Roth (D-Riverside) and Assembly Member Sabrina Cervantes (D-Corona) championed this measure because their districts are home to California's most recently incorporated cities that lost crucial VLF funds in 2011. *For more, see Page 2.*

League Opposes Uber/Lyft Bill Restricting Application of Business Licenses to Drivers

Proposed Licensing Scheme "Is Not Cooked"

After some exploratory discussions with representatives of Uber and Lyft, sponsors of SB 182 (Bradford), the League ultimately opposed the measure. This opposition is based on recent amendments that prohibit local agencies from requiring drivers associated with transportation network companies (TNCs) to obtain a business license to operate unless it is the location where they live. On May 9, SB 182 passed the Senate Judiciary Committee, over the objections of its Chair, Sen. Hannah Beth Jackson (D-Santa Barbara), who maintained that the bill "*is not cooked.*" The senator is correct; it's not. *For more, see Page 2.*

Although all cities were affected by the loss of city shares of VLF, these four cities were hit hardest because they were much more reliant on VLF than the other 478 California cities. This is due to prior legislative tinkering with local revenue sources.

League-supported SB 130, is similar to this year's SB 37 (Roth), and allows the four cities to receive allocations of property tax as VLF adjustment amounts that all other cities receive.

The League initially held off in taking a position on SB 182 so that discussions could be held with the sponsors who were seeking additional regulatory clarity for TNC drivers on how to comply with local business license requirements, especially in those locations where a driver may only be operating for a small portion of the time. While no examples have been provided of drivers facing multiple licensing requirements, sponsors communicated their concern that drivers, who are often part-time, could face such requirements in the future. It has become clear given recent amendments that the sponsors' objectives are now at odds with those of local government.

The League's starting point for this discussion is that a local business license must have a nexus with business activity within that jurisdiction. For example, San Francisco has over 20,000 TNC drivers registered for business licenses. If a TNC driver works primarily in San Francisco, they clearly should have a business license in that city. The remaining policy question is to what extent should business licenses be required to reflect activity in surrounding jurisdictions? Since TNC companies have locational data on every pick up and drop off, a system could certainly be devised to clarify this area of law, including the concept of apportioning licensing requirements and revenue based on varied levels of business activity.

As amended, however, the requirements in SB 182 have lost all connection to nexus. It now requires TNC drivers to only be licensed in the city or county where they live. This makes no sense. A driver could happen to live in Vacaville, but work in San Francisco driving 60 hours per week. In this instance Vacaville would have little nexus to levy a local business tax; San Francisco, however, clearly would, but would be prohibited by the bill from doing so.

The League is also concerned about the precedents in the bill and how they could affect other local licensing authority. Legislators should vote "No" on the bill in its current form, so that solutions can be developed that more appropriately balance the challenges of this emerging industry with the authority of local agencies to appropriately license business activity within their jurisdictions. Cities are encouraged to submit letters of opposition.

Assembly Bill Strengthening Cities Ability to Use Inclusionary Housing Tool for Rental Units Moves to Senate

California cities are on the front lines of the state's housing crisis and need tools to help encourage the development of more affordable units for residents. AB 1505, a bill that clarifies and strengthens cities' authority to use the inclusionary housing program for rental units is on its way to the Senate.

Assembly Member Richard Bloom (D-Santa Monica) is authoring this bill because he believes that local governments need more options to help address the housing crisis. He made this point again in a May 4 [press release](#) following the Assembly's vote on the measure: "Housing costs across the state have increased exponentially and absent corrective action there is no end in sight," said Assembly Member Bloom. "Given our state's severe housing crisis, it is critical that we give local governments every tool to address affordable housing needs. This bill returns one of our most important and effective tools."

This League-supported bill gives cities more opportunities to increase their affordable housing stock. The measure clarifies that under the law, cities have the option to impose inclusionary housing programs for both for sale and rental housing developments.

These programs would help meet the affordability needs of residents despite developer resistance. This measure would also complement the additional pending bills that seek to bring much needed financial resources to affordable housing programs.

Background

In the California Court of Appeals decision in *Palmer/Sixth Street Properties L.P. v. City of Los Angeles*, 175 Cal. App. 4th 1396 (2009), the court took a very broad interpretation of the Costa-Hawkins Act and its application on inclusionary housing ordinances, opining that inclusionary housing ordinances with regards to rental housing conflicted with and were pre-empted by the Costa-Hawkins Act. Costa-Hawkins was intended to restrict systems of rent control, not preclude rent restrictions on inclusionary housing.

Next Steps

June 2 is the Legislature's House of Origin deadline. After that date, bills that have moved to their second house will be scheduled for committee hearings. Expect those hearings to ramp up in early to mid-June. The League will keep cities notified of AB 1505's hearing schedule.

Senate Energy, Utilities and Communications Committee Holds Hearing on 100 Percent Clean Energy Bill

SB 100 Sets State Target for Renewable Energy to 100 Percent by 2045

Senate President pro Tem Kevin de León's (D-Los Angeles) proposal to have California reliant on 100 percent clean energy by 2045 cleared its first policy committee hearing a week after being introduced. [SB 100](#), according to the Senate President pro Tem, sets the most ambitious renewable energy target in the world. The committee on May 9 passed SB 100, sending it to the Senate Appropriations Committee.

During the hearing committee members and stakeholders engaged in a lengthy discussion on the legislation and its impacts on the state, jobs, utilities and industry. Wind energy, the solar industry and employee unions led the charge in support of the measure, while investor owned utilities voiced concerns. Committee members and stakeholder groups alike seek consideration of additional energy sources, such as geothermal, biomass, and renewable gas. Conversations will continue as this bill moves through the Legislature.

Announced on [May 2](#) during a [press conference](#) featuring Sen. de León along with Sens. Hannah-Beth Jackson (D-Santa Barbara), Scott Weiner (D-San Francisco), Henry Stern (D-Agora Hills) and William Monning (D-Carmel), SB 100 is being touted as a measure that addresses climate change, while also supporting California's economy and job creation. Sen. de León promised that Californians can expect savings on their utility bills when SB 100 is implemented.

SB 100 expands the existing Renewable Portfolio Standard (RPS) and directs three state agencies, the Public Utilities Commission, the Energy Commission and Air Resources Board, to adopt policies and regulations to meet the new goals. It also applies to both retail sellers and publically owned utilities.

The Legislature in 2015 passed SB 350 (de León), which set a 50 percent clean energy standard by 2030. Last year's SB 32 (Paveley) requires the state to reduce its overall Greenhouse Gas Emissions by 40 percent by 2030.

Under SB 100, the current 50 percent RPS target will be accelerated with the following further targets established:

- 50 percent by 2026;
- 60 percent by 2030; and
- 100 percent by 2045.

In addition, the measure creates new policies related to the capture of uncontrolled methane from sources including dairies, landfills and waste water treatment facilities. The new clean renewable fuels will replace natural gas. The measure seeks to replace dirty diesel fuels by directing investor owned utilities, to invest in cleaner transportation fuels such as hydrogen or waste methane gas from dairy farms.

League-Sponsored Bond Agency Issues \$66.1 Million in Tax-Exempt Bonds for Affordable Housing in Roseville, Los Angeles and Hospital in Montebello

This program provides a variety of public agencies and developers access to low-cost, tax-exempt financing and economic development tools. CSCDA recently issued a total of \$66,153,000 in tax-exempt multi-family affordable housing bonds for Campus Oaks Phase 1

Apartments in Roseville, Boyle & Jewell Terrace Apartments in Los Angeles and tax-exempt bonds for Beverly Hospital located in Montebello.

About Campus Oaks Phase I Apartments

Campus Oaks Phase 1 Apartments is the new construction of 185 mixed income housing units by Scott Canel & Associates (Canel). The units will include:

- 22 percent of the rental housing units will be rent restricted for low-income tenants;

SB 649 – A “Small Cell” Bag of Empty Promises

Yesterday the League testified in Senate Appropriations Committee in opposition to Sen. Ben Hueso's (D-San Diego) SB 649, a bill relating to the permitting and leasing of public property for installation of “small cells.”

League Legislative Representative Rony Berdugo fired off the following reasons why the proponents' promises of rapid 5G deployment, jobs, and giving locals discretion fall flat, noting that there's:

- No requirement in the bill for the “small cells” to be equipped with 5G or even 4G technology;
- No requirement in the bill for the “small cells” to be deployed in unserved and underserved communities of the state; and
- Complete discretion over “small cell” installation is limited to only coastal zones and historic districts.

He further explained why every other community will suffer from losing the benefits of complete discretionary review, such as:

- Requiring small cells to blend into their environment, such as palm trees or paint colors on decorative infrastructure;
- Preventing small cell installation outside of areas that may obstruct the view from someone's home or from installing other technology on the same property without “substantial evidence” for needing to do so;
- Negotiating a public benefit, such as access for police, fire, and library services;
- Requiring regular maintenance, maintenance during certain hours of the day, or repair/replacement of broken or dilapidated “small cells;” and
- The ability for cities to improve the character of their communities and their ability to attract business, especially for communities that have been historically marginalized.

He concluded by informing the committee about the dangerous precedent SB 649 would set by eroding the ability for local governments to leverage public property to achieve the greatest public benefit, such as generating flexible general fund revenues to pay for services such as police, fire, and libraries or for providing network access to first responders. While cities across the state are welcoming the wireless industry into their communities, embracing new technologies, such a rollout should not happen at the expense of public input and local collaboration.

The League's full testimony is available to watch.

Next Steps

The bill has until May 26 to clear the fiscal committee deadline should the bill pass out of committee before it heads to the Senate floor for a vote.

Cities are encouraged to contact legislators immediately and oppose SB 649. This is crucial if cities will be able to retain full discretion and ability to charge fair market rates over publicly owned property.
