#### **OBJECTIVE**

The purpose of this memorandum is to provide details about the upcoming Urban Land Institute Technical Assistance Panel (ULI TAP), who will be assisting the City of Garden Grove with a market assessment for the Valley View Business Corridor. The ULI TAP is scheduled on July 18-19, 2018.

#### **BACKGROUND**

Since 1947, ULI's Advisory Services Program has been assisting communities by bringing together panels of seasoned real estate, planning, financing, marketing, and development experts to provide unbiased pragmatic advice on complex land use and development issues. At the local level, the ULI Orange County/Inland Empire District Council provides advisory services panels on specific issues, which are addressed in one or two days.

The panel consists of professionals, who are ULI Orange County/Inland Empire members, with expertise relative to the scope of the project. All TAP panelists are volunteering their time and expertise to participate. Sponsors request TAPs and the District Council assist the sponsor in refining the scope of the assignment and in organizing the panel's efforts. At the conclusion of the TAP, the panel issues a report with findings and recommendations to the sponsor.

#### **DISCUSSION**

ULI has partnered with the Association of California Cities Orange County (ACC-OC) to sponsor the 2018 ULI TAP. In May 2018, the City had submitted two applications for consideration: 1) the South Harbor Corridor Assessment, and 2) the Valley View Business Corridor to assist with a market assessment. ULI has selected to work with the City of Garden Grove on the Valley View Business Corridor efforts.

The two-day session has been scheduled on July 18-19, 2018. The ULI TAP will be assisting the City of Garden Grove with the following scope of services:

- Conduct an assessment of Market Viability for the Valley View Business Corridor;
- Conduct a review of existing land-use and zoning;
- Prepare strategic recommendations to address sustainability and encourage longterm retail and commercial reinvestment;
- Assist in development of a framework for vision and marketing for the Valley View Business Corridor; and,
- Facilitate community engagement efforts.

There is no cost to the City for the ULI TAP study. City staff will help facilitate site tours and coordinate focus group meetings. The preliminary agenda for the two-day sessions is summarized below:

**Day 1 Activities:** Conduct "tour" of the study site(s) and coordinate focus group engagement meetings with ULI TAP.

**Day 2 Activities:** Working session for ULI TAP to finalize recommendations, findings and presentation. Presentation to the City of Garden Grove is scheduled on Thursday, July 19 at 5:30 p.m. in the CMC (B Room).

In addition, the Valley View Business Corridor findings prepared by the ULI TAP will be presented to the ACCOC in their July meeting.

#### SUMMARY

The City appreciates the opportunity to collaborate with ULI and welcomes the assistance of their seasoned real estate, planning, financing, marketing, and development experts in preparing a market assessment for the Valley View Business Corridor. # PRELIMINARY SCOPE OF WORK ULI Technical Assistance Panel (TAP) Study for the Valley View Business Corridor in the City of Garden Grove

#### 1. Market Viability (Reality Check)

- a. ULI to assist in the assessment of the existing retail market conditions of the "Valley View Business Corridor" including but not limited to: a SWOT analysis to ascertain future retail demand, potential retail at-risk, and impact of the shrinking retail market conditions.
- b. ULI to review existing community demographics and share how it translates to consumer behavior and future market trends.

#### 2. Assessment of Land-Use and Zoning

- a. ULI to conduct a comprehensive review of the existing land uses of the identified commercial properties along the Valley View Business Corridor.
- b. ULI to conduct a comparison of the zoning and General Plan Designation(s), and assist in determining potential modifications to best address future and/or anticipated development patterns and uses.
- c. ULI to prepare strategic recommendations to address sustainability and to encourage long-term retail and commercial "reinvestment" to the Valley View Corridor area including development opportunity scenarios that is in-line with current market trends.
- d. Given the limited resources, the scope of work has been limited to the following commercial uses to be part of the Valley View Business Corridor:
  - i. Eastern Gateway, Next Level Sports Complex located at 12821 Knott Street
  - ii. Southern Gateway, Bridgecreek Center located at 12802 Valley View Street
  - iii. Shakey's anchored retail center located at 12540 Valley View Street
  - iv. Rite Aid anchored retail center located at 12491 Valley View Street
  - v. Former AMF Valle View Lanes center located at 12141 Valley View Street
  - vi. Eastgate Plaza Shopping Center located at the north west corner of Valley View Street and Chapman Avenue

#### 3. Visioning and Marketing (Branding)

- a. ULI to assist in the development of a framework for a visioning and marketing strategy for the Valley View Business Corridor with emphasis towards business attraction initiatives, marketing opportunities, and visioning tools to assist legacy property owners.
- b. ULI to develop an outline for a marketing plan to promote the Valley View Business Corridor and develop a potential "brand" to celebrate the small business entrepreneurs.

#### 4. Community Engagement

- ULI to facilitate community engagement in focus groups and/or interviews with key community stakeholders with consideration of incorporating an interactive online community engagement tool and/or an interactive survey.
- b. ULI to assist in the programming of a Collaborative Outreach Excursion to engage local community stakeholders to explore successful commercial and mixed-use developments.

#### 5. Tentative Timeline

In coordination with ULI, ACCOC and the City of Garden Grove, conduct further discussions to determine presentation of the TAP findings in July.

### Streetcar Vehicle Selection is Rolling Forward

The OC Streetcar is rolling forward with the selection of Siemens Industries to manufacture and deliver the vehicles that will carry passengers along the 4.15-mile route from Santa Ana to Garden Grove. In March, the OCTA Board of Directors approved the \$51.5 million contract for eight vehicles, system support, training, and spare parts and tools. Six vehicles will be in operation and two spare cars will rotate in as needed.

The streetcar model chosen, S70, has proven effective in eight cities across the country. Measuring 88 feet long, each vehicle has four double-width doors on each side and can carry 181 passengers. Special platforms built into each streetcar will allow level boarding without steps, ramps, or bridge plates.

Designs and paint schemes for vehicles and stops will be available for public review later this year.

### Pre-construction Activities Underway

Pre-construction activities have already begun around the corridor. Utility companies, such as telecom providers, Southern California Edison, and the Gas Company have been potholing, relocating services on power poles and other activities to prepare for OCTA's contractor to begin later this year.

Upcoming utility relocation work will require temporary lane and parking restrictions for drivers; however, access to all businesses and residences will be maintained. OCTA will provide notification for most activities; however, there may be limited service outages that will be noticed directly from the utility to their customers.

OCTA is expected to select a contractor later this summer and work on the Maintenance and Storage Facility and track work will begin in early fall.

### U-Haul pickup pursuit from Garden Grove ends in Cajon Pass with driver fatally shooting himself

The driver of a white U-Haul pickup being pursued by the California Highway Patrol pulled over to the side of the 15 freeway in the Cajon Pass and fatally shot himself Wednesday afternoon, police said.

The pursuit began shortly before 5 p.m. in Garden Grove when someone at a business in the 12800 block of Joy Street called police and advised them that a family member was expected to drop off stolen firearms — handguns and a shotgun — at the business, said Lt. Carl Whitney, a Garden Grove police spokesman.

"He was afraid something might happen, so he asked us to come out and keep the peace," Whitney said. The family member told Garden Grove police that the firearms were stolen from his Fullerton residence in 2017.

Officers arrived and learned the suspect was knocking on the back door of the business as he tried to get the person at the business to come outside, police said.

As officers approached the business, the suspect fled in a white GMC U-Haul pickup.

Officers followed the truck, and the driver initially pulled over near Brookhurst Street and Lampson Avenue. But then he took off, and officers pursued the truck to the Orange County border. An Anaheim police helicopter was involved in the pursuit.

The pursuit made its way through Orange and Riverside counties on the 91 freeway before entering the northbound 215 freeway, continuing into San Bernardino County.

CHP officers pursued the pickup on the north 215 to the north 15 into the Cajon Pass. After CHP officers deployed spike strips, the driver's side front tire blew out while in the Cajon Pass and quickly shredded, throwing chunks of rubber onto the freeway. Officers conducted a traffic break to hold traffic behind the pursuit.

The driver of the pickup, who appeared to be a white man wearing a light-colored shirt and smoking cigarettes, pulled into a dirt area off the 15 freeway at 6:02 p.m., in the area of Highway 138, ending the pursuit. CHP officers attempted to engage the driver, but the suspect shot himself, Garden Grove police said in a news statement.

The suspect received medical aid at the scene and was transported to Desert Valley Hospital in Victorville. He was pronounced dead at 6:37 p.m., the Garden Grove police statement said.

Whitney said a semi-automatic gun and a gun safe were found in the vehicle.

The lieutenant said Garden Grove police had no prior contact with the suspect before Wednesday. The suspect's name was not immediately released by authorities, but Garden Grove police said he was 42 years old.

# Orange County cities propose homeless shelter sites to Judge Carter

Three Orange County cities have proposed building a handful of emergency homeless shelters that would house up to 700 people.

The announcement of the new shelters proposed in Anaheim, Huntington Beach and Santa Ana came Wednesday morning in U.S. District Court David O. Carter's courtroom in Santa Ana.

Carter gathered mayors, city managers, police chiefs and other representatives of Orange County and its 34 cities to share their progress at addressing a homeless situation residents and officials say has mushroomed in recent years, resulting in public encampments along the Santa Ana River Trail, in the Santa Ana Civic Center and along railroad tracks in several cities. He cautioned officials during the morning portion of the court hearing not to give details on locations at that time.

Carter is overseeing a lawsuit brought on behalf of several homeless people who were living along the river trail when the county began a major effort to clear the encampment early this year.

The plaintiffs argued there was nowhere for them to go because the county has a shortage of affordable housing and its emergency shelter beds can't accommodate people with certain disabilities.

On Wednesday, Carter also heard from Orange County Supervisor Andrew Do, who presented a plan to build 2,700 units of affordable permanent housing over seven years at a cost of \$930 million. Funding sources would include federal and state grants, but a gap of several hundred million dollars remains.

No specific sites were mentioned for the affordable housing, but Do said they should be spread around the county rather than concentrated in a few cities.

Do also proposed the county and representatives of its north, central and southern cities could form a joint powers agency to coordinate their efforts and boost access to funding.

Carter said he's pleased with the progress officials are making at forging a comprehensive plan to provide shelter and services, but noted they're not yet finished.

After comments in open court, Carter continued discussions with city and county officials privately in his chambers well into the afternoon.

Outside the courthouse, Anaheim Councilman Jose Moreno said staying mum about shelter sites for now is important because some cities may still be negotiating with property owners or nonprofit groups that would run the shelters, and ultimately the plaintiffs will need to sign off on whatever solution is reached.

As to how Anaheim residents might react to proposed shelters in their city, Moreno said he hopes residents will "listen thoughtfully."

"I think at the end people want solutions," he said. "The alternative is what we have now."


Inflation in Los Angeles and Orange counties was rising at a 4.1 percent annual rate in May, the highest in nearly a decade.

The latest reading of the two-county region's Consumer Price Index is far above the 2.8 percent gain for all of 2007 and just below the most recent high of 4.5 percent in September 2008.

Here are seven inflation trends you should be watching ...

- 1. Overall housing costs in Los Angeles and Orange counties rose 4.8 percent in a year while the rent index was up 5 percent.
- 2. L.A.-O.C. gasoline cost 23.4 more in the year. Household energy cost 2.5 percent more.
- 3. Food costs rose 1.6 percent in a year. Eating out expenses rose 3.4 percent.
- 4. Medical bills were 2.5 percent higher.
- 5. Apparel prices were 0.4 percent lower.
- 6. Nationally, the average U.S. city saw consumer prices rise 2.8 percent.
- 7. A new Consumer Price Index for Riverside and San Bernardino counties shows inflation up 1 percent between May and March. Prices in the L.A.-O.C. area rose 0.8 percent in the same period while U.S.city inflation rose 0.8 percent.







reflection of our emphasis on STEAM instruction and a testament to the hard work and talent of our students and teachers."







<u>MATTERS FROM COMMISSIONERS:</u> Commissioner Salazar expressed her concerns regarding both commercial and residential parking issues and suggested staff look beyond today's minimum parking requirements, as current parking standards may not work in the future.

Staff responded that State Density Bonus projects have constrained parking requirements in order to obtain the low income units due to parking being expensive to provide, therefore parking is limited. Staff pointed out that the City was undergoing a downtown parking plan study consisting of counts and surveys of old and new uses that generate a variety of parking styles, and, to finance a parking structure, people would need to pay for the parking.

Commissioner Kanzler commented that philosophically, more buildings for lower income residents, smaller spaces, and an increase in available public transportation were key to solving the parking problems.

Chair Brietigam commented that we live in a car culture, though other transportation options should be encouraged.

Staff then explained that there was plenty of parking around Main Street and that a vital Main Street would be one in which there were more people than cars. At its peak, the west parking lot was only 55% full. Another example, with new residential Accessory Dwelling Units (ADU's), only one parking space would be allowed if the distance to the nearest bus stop was beyond half of a mile. Staff then noted that state laws limit the Planning Commission's discretion in parking matters and suggested zoning training for Commissioners on a one on one, or group meeting basis.

Chair Brietigam then mentioned that the paint on a two-story building located at northeast corner of Western Avenue and Acacia Avenue needed refurbishment. Staff would have Code Enforcement look into the matter.

Chair Brietigam then suggested that the City recycle the extra street light poles, from the Verizon and Sprint projects, to be utilized in dark lit areas which could be designated by the Police Department. Staff added that typically, to add a light to a street, the neighborhood community would fill out a form to submit to Ana Neal in the Engineering Division with the light cost shared among the residents.

Lastly, Chair Brietigam challenged the City to increase the sworn Police staff to 200 by the year 2020, along with five additional firefighters.

MATTERS FROM STAFF: Staff noted that the June 7<sup>th</sup> Study Session on CEQA 101 would begin at 6:00 p.m. Also, for the June 21<sup>st</sup> meeting, staff would like to begin the meeting at 6:00 p.m. The Commission agreed.

## Fight Misguided Effort that Jeopardizes Over 5,000 Road Projects Statewide, Puts Californians' Safety at Risk

June 8, 2018

The June 5 Proposition 69 victory to prohibit the Legislature from diverting SB 1 revenues for non-transportation purposes was just the start of a larger campaign to protect those funds.

In November, voters will likely see an ill-conceived ballot measure that would eliminate billions of dollars of transportation funds by repealing SB 1. More than 5,000 transportation improvement projects are at risk of being halted. This would threaten driver and pedestrian safety, increase traffic congestion, cost jobs and hurt taxpayers.

<u>Voters overwhelmingly passed Prop. 69</u>, sending a strong signal that they want their transportation dollars going only to fund transportation projects. They imposed stronger accountability projections to transportation funds at a time when Californians have clearly communicated that fixing their crumbling roads is a top priority. Those behind this effort to repeal transportation funding and eliminate thousands of road improvement projects do not have the best interests of Californians in mind.

The League and the other members of the <u>Coalition to Protect Local Transportation Improvements</u> is committed to making sure that Californians do not lose the \$5 billion annually going to fix the state's streets, roads, bridges, freeways and transit system.

## Budget Agreement Includes \$500 Million in One-Time Funding for Local Governments to Address Homelessness

Legislative Budget Committee Wrapped Up its Work Late Friday, Full Legislature to Vote on Budget Later this Week

June 11, 2018

On Friday morning, Gov. Jerry Brown, Assembly Speaker Anthony Rendon (D-Lakewood) and Senate President pro Tempore Toni Atkins (D-San Diego) announced that they had reached a FY 2018–19 budget agreement.

The full agreement and associated trailer bills will be finalized this week to meet the Legislature's June 15 constitutional deadline to pass a budget. Positive for cities, the budget includes a one-time \$500 million allocation for local governments for emergency aid for homelessness. This amount is twice the amount the Governor included in his May Budget Revise.

Throughout the budget process this year, the League supported additional funding for cities to address California's growing homelessness crisis. Funding in the FY 2018–19 budget comprises \$500 million in one-time Homeless Emergency Aid Block Grant. This includes:

- \$250 million that can be accessed through the existing Continuum of Care process;
- \$150 million in direct grants to cities over 330,000 population (which have the highest concentrations of the state's homeless population); and
- \$100 million allocated based on local homeless populations to the Continuum of Care.

The final budget also includes a proposal to place the No Place Like Home program on the November 2018 ballot to resolve a legal ambiguity associated with dedicating mental health funding through Proposition 63 (2004) to build 10,000 units of housing for the homeless mentally ill through the No Place Like Home program.

### **Next Steps**

The Legislature will likely vote on the budget on Thursday or Friday. The League will issue its analysis on how the budget affects cities.

### Deceptive Corporate Tax Trick Threatens Quality of Life in Cities, Jeopardizes Local Services

June 14, 2018

Sacramento Mayor Darrell Steinberg is warning that the Corporate Tax Trick initiative is disingenuous.

His warning came during a <u>special hearing of the Assembly Local Government and Revenue and Taxation committees</u> on June 13 to shed light on a dangerous initiative, funded by billion dollar corporations, to shift a bigger tax burden onto families and small businesses while hurting local communities.

Committee Chairs Assembly Member Cecilia Aguiar-Curry (D-Winters) and Assembly Member Autumn Burke (D-Inglewood) convened the hearing. In her opening remarks, Assembly Member Aguiar-Curry emphasized that she looks at policy from the lens of having served as mayor of a small and rural city. "I worry that we (with this initiative) will have some unintended consequences for our smaller communities."

She closed the hearing reiterating the same point. "My concern is that I think of the entire state and the small and rural cities. I don't forget where I came from (local government)."

Mayor Steinberg's powerful testimony focused on how he is working to transform Sacramento's economy and the ways in which this proposal would devastate his city and others. "It is disingenuous and a gross overreach," said Mayor Steinberg.

He called it an abuse of authority and cautioned that it will have dramatic consequences for cities that are trying to do the right thing. Sacramento could have a \$50 million hole in its budget and that will force service cuts and the loss of police and fire.

Terry Brennand with SEIU stressed that the Corporate Tax Trick is not a taxpayer revolt. "This is a thinly disguised effort to thwart local efforts to make them (corporations) pay for their impacts on communities."

"It's really clear that this measure favors the interest of the sponsors and it's a vast overreach," testified League Legislative Director Dan Carrigg.

Assembly Member Richard Bloom (D-Santa Monica), a former Santa Monica mayor and council member, expressed his outrage. It (the Corporate Tax Trick) wants to block the will of the people and what kind of democracy do we live in where we try to institutionalize it and institutionalize it at the instance of a few

corporations who want to see that happen?" ...

### **Coalition Forms to Oppose Corporate Tax Trick**

The League is part of the <u>Committee to Protect Our Communities</u>, a coalition of local government and union groups that formed to oppose the Corporate Tax Trick. If it qualifies for the November 2018 ballot, citizens will need to know that it is the opposite of taxpayer protection by making it possible for special corporate interests, such as Big Soda and Big Oil, to avoid paying the fees and taxes they currently pay, even when their business harms local communities or hurts the environment.

The Corporate Tax Trick would undercut local voters' ability to determine what local investments are important and instead gives corporations a "free lunch" by letting them not pay their fair share for the impact of their business on California communities. The measure's provisions would put essential municipal services — public safety, healthcare, libraries and infrastructure — at serious risk.

The corporations behind this proposal do not have the interests of families, small businesses and the communities they call home at heart. Funders, who have already dumped millions of dollars into the effort to gather signatures of the measure, come from oil, insurance, pharma, soda and others. The largest funder is the American Beverage Association, which spent over \$25 million two years ago in California trying to defeat, unsuccessfully, local soda tax initiatives to prevent childhood obesity and improve the health of communities.

### Fight the Corporate Tax Trick and Support CitiPAC

The League is calling on California city officials to help fight the Corporate Tax Trick and there are several ways to get involved:

- **Join the coalition:** Visit the campaign website (<a href="https://protectourcommunitiesca.com">https://protectourcommunitiesca.com</a>), and join the coalition's efforts to make sure this ill-conceived proposal doesn't hurt California.
- Support CitiPAC: Contributing to <u>CitiPAC</u> is another way to get involved with the League's efforts at the ballot box. CitiPAC is the League's political action committee that raises resources to advocate on ballot measures. Unlike candidate PAC's, CitiPAC funds can only be used to advocate on statewide ballot measures. The funds are never used to support candidates for office. CitiPAC funds are raised through individual contributions from city officials and employees as well as through sponsorships of events throughout the year. The most direct way that city officials, staff and others can support CitiPAC and the League's advocacy efforts is through a personal financial contribution. These funds will be used to pay for things such as signature gathering, mass media and communications, campaign consultants and voter engagement.

### Learn about the League's 2018 Ballot Measure Activity

This is a crucial year for cities at the ballot box and in addition to opposing the Corporate Tax Trick, the League is involved in several other measures on the November statewide ballot.

After voters overwhelmingly passed Proposition 69 in June to put a lockbox on transportation funds, the League and the Coalition to Protect Local Transportation Improvements, have already begun to fight an effort to repeal SB 1, the transportation infrastructure funding package. Thousands of transportation improvement projects statewide could be halted if the over \$5 billion of funding that SB 1 generates annually is taken away. This would jeopardize public safety, worsen congestion, cost drivers and taxpayers more in the long term and hurt job creation and the economy.
