#### **OBJECTIVE**

To provide information on coyote activity in the City and provide an update of City actions to manage the aggressive coyote population in the City.

#### **BACKGROUND**

Three years ago the City began efforts to manage the aggressive coyote population within the City. Coyotes were spotted in areas of the City and were killing small pets resulting in numerous citizen requests for City action. Staff investigated the issue and began a Coyote Management Plan to address the various concerns. The plan consists of two main parts:

- Proactive public education regarding safety and prevention against coyotes including: 1) reducing coyote attractants such as leaving out pet food and securing trash cans, 2) pet security measures such as keeping pets indoors at night, closing pet doors and main doors and accompanying pets outside and 3)using hazing behaviors to scare away coyotes and re-instill their fear of humans.
- Hire a consultant to assist with issue identification and if needed to proceed with abatement action.

#### **DISCUSSION**

Within the last few weeks, the number of coyote sightings and reports of coyote pet killings and aggressive behavior has increased significantly. In response, staff has activated the Coyote Management Plan again. Staff has begun the resident education program and has issued a coyote alert to the news and social media.

The City is also renewing its contract with Animal Pest Management Services for coyote management services and expects to have them on board before the end of August. The contractor will identify coyote locations and review the coyote entry points into Garden Grove, particularly in the West Garden Grove area. contractor will make recommendations to eliminate new entry points of coyotes to Garden Grove, if found, or make recommendations of other means to keep coyotes out of Garden Grove neighborhoods. Staff will review the consultant's COYOTE MANAGEMENT PLAN UPDATE August 3, 2016 Page 2 of 2

recommendation on coyote entry issues when they are made available and Public Works will begin to address any recommendations as soon as possible.

Finally, the contractor will make a recommendation on trapping or abatement action. The contractor, following consultation with and approval of City staff, will proceed with trapping and abatement activities.

#### Garden Grove man receives probation for

#### smuggling Asian songbirds into U.S.

A Garden Grove man who smuggled 27 Asian songbirds into Los Angeles International Airport was sentenced July 25 to three years' probation.

Due to Can Thanh Nguyen's poor health, U.S. District Judge Michael Fitzgerald in Los Angeles opted to sentence him to supervised release, including eight months of home detention, rather than time behind bars.

Nguyen, 63, was arrested April 20, 2015, after border officials found the birds, 11 of which were in a suitcase, hidden under a layer of clothes. Other birds were found hidden in cages wrapped in foil or newspaper.

Eleven of the birds were determined to be protected Chinese hwamei.

Ten of the birds were dead when they arrived or died soon afterward. The rest were turned over to the U.S. Fish and Wildlife Service, authorities said.

Assistant U.S. Attorney Dennis Mitchell argued that Nguyen deserved prison time.

Nguyen took "27 helpless creatures... cramming them into a suitcase" and sending them into an international flight's cargo hold "where temperatures are subfreezing," the prosecutor told Fitzgerald.

Such birds sell for up to \$400 each at Chinese markets in Southern California.

Defense attorney Georgina Wakefield countered that a probationary sentence was appropriate based on Nguyen's age, poor health, lack of funds and time spent in a prison camp after the Vietnam War.

"He has had a rough life, as many residents of Little Saigon have," the judge said.

He faced a maximum sentence of 20 years in prison.

## Funding plan for OC Streetcar climbs \$9M


orange • County transportation officials July 25 approved an increased capital funding plan for the OC Streetcar project ahead of a deadline to secure a federal grant.

With 30 percent of the design completed, the OC Streetcar, with 10 stops in Santa Ana and east Garden Grove, has seen a 3 percent – \$9 million – cost increase, to \$297.9 million.

The increase is owed to elements that will enhance system operations and maintenance, said Mary Shavalier, OC Streetcar project manager for the Orange County Transportation Authority. They include additional track on North Ross Street between West San-

ta Ana Boulevard and West Fourth Street for a shortened route, improving a maintenance facility and adding a "truing" machine, to correct imperfections in wheels that occur over time.

Transportation authority staff plans to submit the revised capital funding plan, which only OC-TA board member Todd Spitzer opposed to the Federal Transportation Administration by the Sept. 2 deadline for the next round of New Starts program analysis. In February, President Barack Obama, under Starts, included \$125 million for the streetcar in his proposed federal budget for the 2016-17 fiscal year. OCTA is seeking about \$148.5 million in New Starts money.

The community is encouraged to report coyote sightings by calling the city's coyote hotline number at 714-741-5286. Callers should include date, time and location of sightings. If the coyote is posing an imminent threat to life, call 9-1-1.

According to the California Department of Fish and Wildlife, during the warm summer months, particularly from March through August, coyotes are very active. They are raising their young and searching for food.

Fish and Wildlife indicates that coyotes are highly adaptable and often live in close proximity to populated areas where food and water sources are abundant. They usually fear humans and avoid interactions, however, if they associate humans with food, they lose their natural fear and can become hold Some coyote safety rips from the CDFW are

### 5 THINGS TO KNOW

A building boom might have reached a tipping point.

Orange County hotels: Too much new stuff?

A hotel building boom is underway, but that development raises questions as to whether there's enough tourism business to keep local hotels profitable.

Here are questions to ponder:

1. How much is being built?

Orange County added more new rooms in 2016's first half than any other California market, says a new report from the hotel trackers at Atlas Hospitality Group in Irvine.

Orange County has 1,078 new rooms at four hotels: the 603-room Great Wolf Lodge in Garden Grove; 250-room Pasea Hotel & Spa in Huntington Beach; 129-room Homewood Suites in Aliso Viejo; and the 96-room Holiday Inn Express in Anaheim.

That's not all. Atlas says Orange County has 12 hotels with 2,089 rooms under construction, topped by the 274-room Residence Inn in Anaheim. Plus, Orange County has 31 hotels with 6,385 rooms in plan-

ning.

#### 2. Is that odd?

Orange County isn't unique. A hot tourism market has lured numerous developers into hotel building.

Nationwide, 1,259 hotel projects are underway, representing a yearover-year increase of 27 percent in the number of new rooms being

The big question: Are hotel owners meeting rising demand? Or will they flood the market?

Atlas analyst Alan Reay is nervous the industry may be overdoing construction.


"I think we may be close to overbuilding," Reay says.

#### 3. Buy or build?

In Orange County, for example, a wild market to buy hotels means the properties sell at a value equal to

roughly \$134,000 per room, according to Atlas.

Development costs for a new project – land plus construction – run at the purchase-price level or lower, nudging many hotel owners to grow a portfolio by building new product, Reay explains.

But too much supply will either cut room rates or lower occupancy, Reay guesses. That could create financial headaches for the industry.

"Hoteliers seem to go through

this every cycle," he says.

Problems may first hit owners of older hotels that don't have the modern bells and whistles. And Reay says overbuilding fears raise questions as to why Anaheim is backing four luxury hotel projects near Disneyland with tax breaks.

#### 4. How's business?

The once red-hot local hotel market is good but cooling, according to CBRE Hotels.

Countywide room rates are up

2.5 percent in the first five months of the year vs. 5.7 percent for all of 2015, and 6.5 percent in 2014. Occupancy is relatively flat – 79 percent through May, up 1 percentage point in a year.

So the easy profits are gone. A key cash flow measure "RevPAR" is up just 3.7 percent this year. Not bad, but below 2015's 8 percent annual growth and 9 percent of 2014.

#### 5. Are too many rooms the only problem?

Local hotels' ability to push rates higher, while keeping vacancies low, is being challenged.

This cooling is not simply due to new supply. A pullback in the flow of foreign tourists to the region, as well as tighter corporate travel spending, means "No Vacancy" signs aren't as commonly seen.


Of course, excess supply is good for local visitors who may reap favorable room rates and/or better selection of hotels.

But for hotel owners – or those who bet on the industry – their own energy, in the form of a building boom, could become a problem.

## And even better news: 'We expect the trend to continue,' says a spokesperson with AAA.

Expect long lines at Costco and Berri Bros. this weekend as the chains offer gas around \$2.30 a gallon.

Orange County's average gas price Thursday was \$2.80 a gallon – down 7 cents in a week, 17 cents in a month and \$1.35 compared with this time last year.

In Los Angeles and Long Beach, gas Thursday was \$2.81 a gallon – down 7 cents in a week, 16 cents in a month and \$1.34 compared with this time last year.

In the Riverside-San Bernardino area, the average price of gas Thursday was \$2.77 a gallon – down 7 cents in a week, 13 cents in a month and \$1.32 compared with this time

last year.

"We're seeing a lot of reports now of larger-than-normal gasoline inventories, and that's good news for drivers," said Marie Montgomery, a spokesperson at the Automobile Club of Southern California. "It's bringing the price down locally and nationally. We expect the trend to continue."

GasBuddy petroleum analyst Allison Mac added that refineries in the area are producing at full capacity and trying to get rid of summer blend ahead of the winter months.

"We are getting ready to switch over to winter-blend gasoline, so we are trying to get rid of inventory," Mac said. "Early October is when gasoline can be winter blend. It's like last-season clothes at Nordstrom. You can get this gas at a discounted price."

Wholesale prices have dropped 40 cents since July 1, so Montgomery expects price to fall relatively quickly.

"We're entering a lower demand time of year, so that will also put some downward pressure on prices as well, and as long as there is adequate supply of the summer blend, which needs to last through Oct. 31, then we will see further price decreases into the fall," she added.

The highest price in O.C. reported to Gas-Buddy was \$3.59 a gallon at a Valero station at 105 E. Lincoln Ave. in Orange. A few other stations also show prices over \$3.20 a gallon.


Several local stations, mostly Costco and Sam's Club, are offering their members gas at prices nearly a dollar cheaper. On Thursday, Costco in Huntington Beach was offering gas for \$2.29 a gallon, roughly 50 cents below the county average.

Montgomery said price outliers are not uncommon. People looking to fill up should aim to pay \$2.40-\$2.50 a gallon for gas.

"You should easily be paying under \$2.50 a gallon in most Orange County cities right now," she said.

The crash knocked out power to 16 Southern Caliornia Edison customers, said power company spokeswoman Lois Pitter Bruce.

### LAMPSON AVENUE STORM DRAIN CONSTRUCTION TO BEGIN

Lampson Avenue, from West Street to Merrill Street is set to undergo construction beginning August 8, 2016 through September 2016. The improvements, when complete, will help to alleviate flooding on Lampson Avenue at the Merrill Street intersection.

### RECENT COYOTE SIGHTINGS PROMPT WARNINGS, PREVENTION

Recent coyote sightings in Garden Grove have prompted the City to make local residents aware of coyotes in the area, urging them to take needed precautions to protect themselves, their pets, and their property against these wild animals.

The community is encouraged to report coyote sightings by calling the City's coyote hotline number at (714) 741-5286. Callers should include date, time, and location of sightings. If the coyote is posing an imminent threat to life, call 9-1-1.

According to the California Department of Fish and Wildlife (CDFW), during the warm summer months, particularly from March through August, coyotes are very active. They are raising their young and searching for food.

The CDFW indicates that coyotes are highly adaptable and often live in close proximity to populated areas where food and water sources are abundant. They usually fear humans and avoid interactions, however, if they associate humans with food, they lose their natural fear and can become bold.

Some coyote safety tips from the CDFW are:

- Keep small pets inside particularly at dawn and dusk when coyotes are most active.
- Keep pet food and water dishes inside.

- Secure food and trash at all times and remove all sources of water.
- Pick up fallen fruit and keep compost piles tightly sealed.
- Sweep up fallen birdseed, which can attract mice and rats, a common food source for coyotes.
- Remove brush, wood piles and debris where coyotes can find cover and where rodents are abundant.
- Install motion-activated lighting or sprinklers.
- If a coyote approaches or acts aggressively, throw rocks, make noise, look big, and pick up small children and pets. Do not turn your back to the animal.

### Legislators Return for Final Month of Session

League Focused on Housing, Transportation and Employee Relations; On Watch for Amendments

Things promise to heat up in Sacramento when the Assembly and Senate resume for their final weeks of the 2015-16 legislative session. Legislators must finish all business by midnight on Aug. 31. Gov. Jerry Brown then has 30 days to take action on legislation. The League has spent the legislative recess preparing for the hard work that must be accomplished on behalf of cities in the culmination of the session. Cities are urged to remain on alert for breaking news from the League and be ready to act. For more, see Page 2.

### 'Legislature Returns' Continued from Page 1...

The League will be monitoring legislative committees, testifying and engaging with stakeholders on legislative developments. Fiscal committees in both houses will hold hearings during the first two weeks of the month. Although technically only floor sessions may be held Aug. 15-31, rule waivers enable committees to convene until the very end to hear last minute amendments and the inevitable end of session gut-and-amends.

"The end of session is not the time to relax," said Dan Carrigg, deputy executive director and legislative director. "Our lobbyists will be on constant lookout for bills or amendments that affect cities that can pop up with little notice."

Here are the official deadlines:

- Aug. 12: Fiscal Committee Deadline. Last day for fiscal committees (Assembly or Senate Appropriations committees) to meet and report bills requesting legislative appropriations to the Assembly or Senate floor.
- Aug. 15 31: Floor Session Only. Legislative committees cannot meet for any purpose without a rule waiver.
- Aug. 19: Amendment Deadline. Last day to amend bills on the floor without a rule
  waiver. This deadline is often associated with the practice of "gut-and-amend" when
  amendments remove the entire contents of a bill and insert new provisions, unrelated to
  the bill's original intent, because it is used frequently right before or on this date. Bills gutand-amended around this time are able to bypass most of the legislative process and
  appropriate oversight.
- Aug. 31: Final Adjournment of the Regular Session. Last day for either house to pass bills. Final recess begins upon adjournment.
- Sept. 30: Governor Bill Signing Deadline. The Governor has until Sept. 30 to sign or veto bills in his possession passed by the Legislature by Aug. 31.

The League's recently updated <u>Hot and Priority Bills</u> List provides an effective way to understand the most pressing legislation lobbyists, the regional public affairs managers and cities will be focused on this month.

A full listing of Senate and Assembly hearings is available online. Hearing times are subject to change. Bill language and any available position letters on legislation can be found through the bill search function on the League's website.

### By Right Housing Proposal

The Governor's By Right Housing proposal was not part of the final budget deal passed by legislators in mid-June. When the Governor signed the FY 2016-17 budget, it was understood that this issue would be brought back in the final weeks of the legislative session. More than 100 cities have officially opposed this proposal and city officials should be on high alert and ready to communicate their significant concerns when the Legislature takes up this debate in August,

This <u>proposal</u> would reduce perceived additional costs and delays associated with the approval of housing developments containing specified percentages of affordable housing by eliminating public input and project-level environmental analysis, restricting design review, and making approvals ministerial. This was tied to the approval of \$400 million for affordable housing, a priority for the Assembly Democratic Caucus. If the Legislature does not act on the Governor's proposal or something similar, the funds for affordable housing will not be appropriated.

The League has argued from the start that eliminating opportunities for public review of major development projects goes against the principles of local democracy and public engagement.

While it may be frustrating for some developers to hear concerns about traffic, parking and other development impacts, those affected by such projects have a right to be heard. Not having such outlets will increase public distrust in government.

### Transportation Funding

As legislators continue to debate transportation funding, road conditions continue to deteriorate. The 2014 Local Streets and Roads Needs Assessment put the <u>unmet funding need for local streets and roads at \$78 billion over the next 10 years</u>. Add to this the fact that in May, the California Transportation Commission formally adopted a five-year state transportation funding plan that cuts <u>\$754 million and delays another \$755 million</u> in highway, rail, transit, bicycle, and pedestrian transportation projects as a result of declining gas tax revenues.

The Fix Our Roads Coalition, of which the League is a founding partner, has been working over the recess. Look for new <u>#TranspoTues</u> tweets and other social media posts focused on how California needs a solid transportation funding agreement that balances reforms, restores lost revenues and constitutionally dedicates new revenues to transportation. Cities are encouraged to take part in this effort by retweeting and posting messages.

This issue is expected to be negotiated in the special session, which does not face the same deadlines and could extend past the adjournment of the regular session. Recently League staff has seen more signs of progress in the Assembly and Senate. However, the issue continues to face an uphill battle and everyone — stakeholders, the Legislature, and the Governor — will need to stay focused to be successful.

### **Employee Relations, Negotiations**

The League is focused on several employee relations bills at the end of session, including AB 2835 (Cooper) and SB 897 (Roth) which could increase costs and mandates on cities. AB 2835 would place numerous new requirements mandating specific types of labor union employee orientations. It would displace employees and threaten fundamental management rights. SB 897 expands 4850 time (workers compensation) by one additional year for police and firefighters in the event of a catastrophic injury at the hands of another while on duty.

Both bills have been moving smoothly through the legislature and are expected to be on the Governor's desk for consideration shortly. Cities are encouraged to carefully review these bills and communicate their concerns to their legislators and the Governor. The League's opposition letter and a sample letter are available at <a href="https://www.cacities.org/billsearch">www.cacities.org/billsearch</a> by plugging AB 2835 or SB 897 into the search bar.

### **Taking Action**

The League uses a variety of tools to keep members up to date on breaking legislative developments. City officials should watch for urgent communication from their regional public affairs managers. They will be sending action alerts complete with sample letters, talking points and other important information.

One of the best ways to respond to urgent League action alerts is through the League's advocacy app that enables city officials to take action on legislation anytime or anywhere. This tool is especially effective in the final days and nights of the session when legislative developments are late breaking and require immediate action.

The app pushes out action alerts and enables users to take direct action right from their mobile devices. Using it, city officials can easily and rapidly respond to action alerts from wherever a city official might be located by receiving an alert directly to their cell phone via text message or push notification.

While anyone in the public can download the League app, the League's Legislative Advocacy section within the app is only available to city officials that volunteer and sign-up to be part of the League's Advocacy Team.

### Next Steps: Act and Be on Alert

As the final four weeks of session begins, cities need to be ready to take action quickly to help advocate on important issues. On Monday, Aug. 1, the League will start the end of session by issuing an updated bills in committee list in *CA Cities Advocate* to help cities plan their engagement. There are additional things cities can do to be effective:

- If city officials are not already receiving updates from the regional managers, they should connect with them to be added to the list.
- City officials can sign up through their regional manager to gain access to the Legislative Advocacy section of the League's app.
- Follow and share messages sent through the League's <u>Facebook</u> and <u>Twitter</u>.
- Make contact with your legislator so that they know you are involved and can be a resource if they are considering legislation and amendments impacting cities.

And finally, cities should mark Sept. 7 on their calendars, when the League has tentatively scheduled a Sign/Veto webinar. This webinar will highlight all the bills that pass the legislature and represent the last chance for cities to weigh in before Governor Brown takes action.

Organized labor attempted to force a gut-and-amend in the final days of the 2015 legislative session to mandate labor union orientations for state and local agencies. That attempt failed in part due to the hard work of the League and a broad public sector coalition opposing the measure.

This year labor groups are back with a modified proposal under the guise of uniformed training for public employees.

Authored by the co-chairman of the Moderate Democratic Caucus, typically a bloc of politically balanced democratic representatives, <u>AB 2835</u> (Cooper) requires cities to adhere to strict employee orientation rules and provide union organizations greater time and discretion with new employees.

Specifically, Assembly Member Jim Cooper's (D-Elk Grove) bill requires that new employee orientations occur within two months of hire and provides union organizations no less than 30 minutes to present within the first hour of the orientation. This measure grants union organizations nearly full discretion over their presentation materials. It does not prohibit a union representative from discussing internal union politics or campaigning, how to vote on upcoming incumbency elections, or prohibits the issues covered by the Public Employment Relations Board's (PERB) long-standing rule for unprotected conduct by employee representatives "that is found to be sufficiently opprobrious, flagrant, insulting, defamatory, insubordinate, or fraught with malice as to cause substantial disruption of or material interference in the workplace" (State of California (Dept. of Corr. & Rehabilitation) (2012) PERB.

Enforcing strict guidelines for employee orientations would create costly logistical and administrative burdens for public agencies. Changes to an employer's orientation content that may vary from the requirements of this measure, would additionally entail prolonged negotiation with union organizations over content and scheduling of the orientation. This will inevitably result in costly fact-finding procedures for cities.

While unions already have rights to negotiate the issue of orientations through collective bargaining, AB 2835 unjustifiably expands that right and creates undue cost and impractical mandates. Public agencies will be in continuous orientation and negotiation mode as the frequency and number of orientations increase.

For employees themselves this measure amounts to longer orientations, disruption in their training and work schedules, and additional travel all of which this measure dictates. The added benefit to employees is unclear.

Moreover, AB 2835 ignores the day-to-day realities of the workplace for both employees and employers: workplace size, hours, location, and number of agency employees.

This proposal would place major burdens on public agencies that will be disruptive, costly, and logistically impractical — all the while stripping cities of their local control without a substantiated argument that employee union membership and interactions is threatened under current practice.

### **Next Steps**

This program provides a variety of public agencies and developers access to low-cost, tax-exempt financing and economic development tools. CSCDA recently issued a total of issued \$16 million in tax-exempt bonds for California College of the Arts (CCA) in San Francisco.

### About California College of the Arts

Founded in 1907 by Frederick Meyer, a German cabinetmaker whose vision was shaped by the Arts and Crafts movement, CCA is noted for the interdisciplinary and breadth of its programs. CCA educates students to shape culture and society through the practice and critical study of art, architecture, design, and writing. Benefitting from its San Francisco Bay Area location, the college prepares students for lifelong creative work by cultivating innovation, community engagement, and social and environmental responsibility.

CSCDA partnered with Stern Brothers and First Republic Bank to provide the \$16 million in taxexempt bonds for CCA. The bonds will be used to build and improve new educational facilities located adjacent to the existing CCA campus.

### Background

CSCDA is a joint powers authority created in 1988 and is sponsored by the League of California Cities® and the California State Association of Counties. It was created by cities and counties for cities and counties. More than 500 cities, counties and special districts are program participants in CSCDA, which serves as their conduit issuer and provides access to efficiently finance locally-approved projects. CSCDA has issued more than \$50 billion in tax exempt bonds for projects that provide a public benefit by creating jobs, affordable housing, healthcare, infrastructure, schools and other fundamental services. ### California City Solutions: Thousand Oaks Develops Successful Youth Internship Program

This story is part of an ongoing series featuring Helen Putnam Award entries. The 2015 entries are available on the League's website as a resource for cities in a searchable database called California City Solutions. Thousand Oaks C.I.T.Y. was submitted in 2015 for the Community Services and Economic Development award category.

Every other year, the Thousand Oaks Youth Commission, an advisory body to the Thousand Oaks City Council, hosts its Leadership Summit. Youth have the opportunity at the summit to share their concerns and ideas with community leaders and the youth commission.

After reviewing the results from the 2012 and 2014 summits, it became clear that high school youth wanted more opportunities for meaningful employment, volunteer service, and internships to help gain hands-on experience outside of the classroom. Many attributed the lack of opportunities to the economic downturn and the fact that adults were accepting positions that would normally be offered to high school students. This left students unemployed and with too much time on their hands especially during the summer months.

The commission voted to create a program in 2014 designed to help high school students obtain meaningful internships. The team researched internships across the nation, developed a plan called Community Internships Training Youth (C.I.T.Y.) that would work with the community, and presented it to the city council. The commissioners produced a basic C.I.T.Y. program outline with four main objectives in mind:

- 1) Provide 11th grade students information to help them make college and career decisions;
- 2) Include a career skills educational component;
- 3) Provide application and interview training; and
- 4) Provide quality internships with meaningful and relevant experience.

The youth realized the value of partnerships and searched for those that could benefit the program in specific areas of expertise. This resulted in a partnership between the city, volunteer youth commission, institution of higher learning, business collaborative, local school district, and a nonprofit.

Each agency provided a representative to meet and develop a memorandum of understanding and details for the program. Each partner, business, and student has a role.

Principal Partners are responsible for establishing and implementing the youth internship program. The general responsibilities include:

- Communicating the goals and expectations of the program to the community;
- Providing resources to support the program;
- Overseeing communication of information and recruit business partners;
- Communicating information to students, collect student applications and select eligible participants to forward to businesses;
- · Developing and conduct interview skills instruction;
- Developing curriculum and conduct life/career skills learning classes;
- Hosting informational and graduation events; and
- Serving as the central source of information and perform administrative duties.

### Businesses that take an intern agree to:

- Provide a job description for recruitment, interview and select interns;
- Provide intern(s) with realistic, challenging assignments that facilitate learning and have a benefit to the business;
- Serve as a mentor, sharing experiences in the career and giving suggestions for entering the profession;
- Meet with intern(s) regularly to guide performance, answer questions, and provide resources related to the intern's work;
- Submit final student and program evaluations; and
- Attend a graduation ceremony.

### Student interns are responsible for:

- Selecting an internship appropriate with career goals;
- Work the required number of hours;
- Learning about and act in a manner consistent with business "culture" and its commitment to a high level of service and its core mission;
- Maintaining high standards of professionalism while at the internship site;
- Seeking supervision and assistance at the worksite as needed;
- Completing academic tasks required to participate in the program; i.e., attend classes;
- Submitting a program evaluation; and
- Attending graduation ceremony.

C.I.T.Y. helps the community by developing young people and introducing them to local businesses and a local college. City leaders hope that it may encourage students to stay and work in the area, which will provide the next generation needed for future sustainability.

For the 2014 summer program, nine businesses participated and 19 students were placed. All program evaluations were positive and all students indicated they believed it will benefit them in the future. Two of the interns were hired as permanent employees. The college experience component encouraged two students to consider college that didn't necessarily have college in their plans. Additionally, one intern created the local public library mobile app, which has become very popular.

The 2015 program showed an increase in participants with 47 students placed at 23 participating businesses. The internships during 2015 offer a wide variety of experiences: senior services, medical services, hospitality, real estate, recreation, educational publishing, manufacturing, library services, engineering, environmental services, administrative services, event planning, journalism and more. In addition to the six partners, the team also placed interns with the Ventura County, Conejo Recreation and Park District, Thousand Oaks Public Library, local nonprofits and businesses.

The Legislature returns today and has until Aug. 31 to wrap up any remaining business from the 2015-16 legislative session. Gov. Jerry Brown then has 30 days to sign or veto any bills that make it to his desk.

Cities will need to remain attentive as we enter the time period of final negotiations on pending bills, with other "gut and amend" proposals appearing in print with little notice. Cities are urged to watch for breaking news alerts from the League and be ready to act. See "Legislators Return for Final Month of Session" in *CA Cities Advocate* from July 29, 2016.

### Prospects Uncertain for By Right Housing Proposal

League Shares Alternative Concepts with Housing Committee Leadership

Since Gov. Jerry Brown unveiled his by right housing proposal, which would pre-empt local discretionary land use approvals of specified housing developments by having all such approvals be considered "ministerial" actions, the <u>League has been a vocal opponent</u> because it would eliminate opportunities for public input and project-level environmental review and restrict design review which are necessary to ensure public transparency, accountability and achieve quality development.

### California APA Offers Free Planning Assistance to Cities

The California Chapter of the American Planning Association (APA) has launched a program to provide pro bono professional planning assistance to financially constrained municipalities and community groups throughout California and Baja California. After extensive studies by the City Managers Department about the growing unfunded OPEB liabilities of cities, the League board of directors acted decisively and approved the issuance of an RFP in 2015 for health insurance technology platform providers to host a new health benefits marketplace. After a competitive RFP process and guided by the city officials on a Health Insurance Exchange Advisory Committee, the League selected Connecture and Willis Towers Watson to provide and operate the League's new Health Benefits Marketplace.

The HBM is a consumer-driven platform that gives options to active employees and retirees, letting them select the best coverage to meet their needs. Cities can choose from a variety of plan options from the best carriers in the state to offer their active employees, including HMO, PPO and consumer-directed plans. To reduce OPEB liabilities, cities can transition their retirees to the individual market through Willis Towers Watson's OneExchange. The platform guides users through the process to select coverage that best suits their individual needs from more than 90 of the nation's leading health insurance carriers. Eligible retirees also are able to maximize their coverage under the federal Medicare program, helping lower costs for their former employer and themselves.

### **Recent Legislative Developments**

Prior to the passage of the budget, the Governor offered legislators \$400 million one-time for affordable housing conditioned upon adoption of his by right proposal. When the budget was adopted, the funding was folded into a reserve account, but no agreement was reached on the by right proposal and legislators left for a one-month summer break.

During the break the Governor's office met with labor, environmental and other groups, but has yet to propose any major modifications to the proposal. With many significant issues outstanding for key stakeholders including housing advocates, labor groups, developers, environmentalists and local governments, prospects for agreement in the final few weeks of the legislative session remain uncertain. The <u>last revised version</u> of the proposal was a draft issued June 10.

### **Major Policy Concerns**

Taking shortcuts with public input may not be a good long-term strategy. A public hearing allows interested community members to inform the decision-makers of their support or opposition to a project and guarantees that property rights will not be impacted without due process. Good design enables a new structure to match a community's character. While it may be frustrating for some developers to address neighborhood concerns about traffic, parking and other development

impacts, those directly affected by such projects have a right to be heard. Public engagement can also lead to better projects. Not having such outlets will increase public distrust in government and additional ballot measures dealing with growth management.

This proposal is purported to be a response to the state's needs for affordable housing, however it also deflects from the reality that the sources of funding affordable housing have slowed to a trickle. California lost over \$1 billion annually in affordable housing money with the elimination of redevelopment agencies in 2011. Funds from the 2006 state housing bond have been exhausted and federal dollars have been declining for decades. This massive withdraw of resources has contributed to our current challenges, yet no significant source of ongoing affordable housing funding is on the horizon.

The League has supported various legislative efforts to develop and restore affordable housing funding. Proposals have included charging new fees on real estate documents, dedicating some of the state's recent surplus revenues, or enacting a housing bond. All of these, however, face political headwinds. Raising taxes requires a two-thirds vote and is never popular, and the Governor has been resistant to major General Fund expenditures and new debt obligations.

Moreover, many laws related to housing planning and approvals are already on the books. Local governments are required to approve affordable housing and exceptions are very limited, but what locals cannot skip are public transparency and environmental laws. Should the by right proposal be approved, it is highly likely that the public would react strongly to the notion of developers evading public input and environmental laws to which all other projects must comply.

Additional problems with the Governor's proposal include the following:

- Many local general plans are out of date because of the financial difficulties local
  agencies experienced during the last recession, and that even when such plans have
  been updated, they have not been developed to the level of parcel-based criteria that
  address site-specific issues, design and environmental analysis.
- The proposal lacks a solid nexus with SB 375 planning efforts that attempt to support transit-oriented development and reduction of greenhouse gas emissions.
- The levels of affordable housing proposed in the Governor's plan are minimal, below what many local inclusionary ordinances require, plus there is a lack of focus on attempting to address the needs for workforce housing especially in the high-cost coastal areas.
- The proposal does not recognize the challenges many locals face in offsetting the costs
  of serving residents of new housing, and a one-time allocation of \$400 million is not
  responsive to the state's ongoing needs for affordable housing resources.

### League Shares Alternative Concepts with Housing Committee Leadership

As legislators look for alternative approaches to the Governor's proposal, the League recently shared some concepts with the offices of the chairs of the legislative committees with jurisdiction over housing issues, on some incentive-based ways to expedite affordable housing development, which include the following recommendations:

- Establish a \$50 million revolving pot of state planning grant funds to support the
  development of up-front specific plans and associated environmental studies on housing
  sites designated by local agencies that are consistent with local planning under SB 375,
  which could be called Workforce Housing Opportunity Zones.
- Ensure that the specific plan process within these locally-identified planning areas offer adequate opportunities for public input.
- Encourage housing affordability goals for these planned areas that are more robust than the Governor's, and also contain a significant component for workforce housing for those of moderate and middle income, especially in the state's high-cost areas.
- When the up-front specific plans and environmental documents are complete for these
  areas, housing projects consistent with those plans can be much more easily approved.
  State law already precludes local agencies from denying affordable projects consistent
  with local plans.
- Offer two types of incentives to local agencies that opt to do these additional plans and approve projects containing affordable and workforce housing:

- Provide an additional property tax incentive equivalent to 10 percent of the increased assessed value of the new housing, by reducing the property tax the city or county would otherwise be required to shift to the state's ERAF fund.
- Establish a state affordable housing matching fund program, where local contributions to affordable housing would be matched with equivalent state funds.

### **Next Steps**

The League will continue to monitor any developments associated with the by right proposal during the final weeks of this legislative session. While agreement on a proposal appears uncertain at the time, things can always move quickly. Cities concerned about this proposal should remain in close contact with their legislators and encourage them to oppose the by right proposal and advocate for alternative approaches that do not attempt to exclude the public or environmental reviews and establish a much more significant and ongoing source of funds for affordable housing.
